The Organic Certification Program of NOFA-NY announces the availability of the updated organic production Standards Manual and Application Packet for 2000. The NOFA-NY Organic Certification Program offers standards for the certification of vegetables, fruits, grains and beans, livestock,

milk production, maple syrup, cheese, yogurt, wine, sprouts, greenhouse production and for companies handling and processing organic products. New in 2000 are standards for the production of Tilapia fish.

The NOFA-NY Organic Certification Program is one of the largest in the Northeast in both number of farms and in acreage certified. The program certifies farms and processors in New York and Pennsylvania and has been growing steadily since its inception in 1984. NOFA-NY offers a highly respected, third party certification process that is well recognized in the marketplace.

With the increase in demand for organic food

sources, organic certification can be a valuable marketing tool for the farmer.

"Many wholesalers, stores and restaurants require certification of the organic foods they purchase. As consumer demand rises so does consumer awareness, and increasingly consumers are looking for certified products as well," said Patricia Kane, administrator of the NOFA-NY program.

Farmer experience in the program has shown organic certification to be particularly valuable when a new farm is working to break into established markets or when an existing farm seeks to expand its production and sales.

able asset for the consumer of farm products. "Without organic certification, the only way a consumer can be sure of how their food is produced is to visit the farm. I don't think many consumers have time for that," said Kane. "The NOFA-NY label on a product is an assurance that it was organically produced and many customers have come to depend on this assurance when making food choices."

The heart of the certification process is the standards manual. It is the standards that outline what practices are acceptable in organic production. Kane pointed out that, "The standards manual is more than just a set of rules for the farmer. The standards manual is a valuable reference for all farmers interested in alternative farming methods, whether or not they have an interest in certification."


