Trucklot buying activity was typically quiet for midweek. Offerings were mixed as some plants reported reduced slaughter schedules due in part to short weights, equipment upgrades and apparent cutbacks in production. Thighs and thigh meat were tight to adequate. Boneless, skinless breasts were becoming increasingly available and some discounting was reported. Bone-in breasts ranged about adequate to fully adequate. The balance was at least adequate. Retail and distributive movement was light to fair at best. The market tone was fully steady to firm on thighs and no better than steady on the balance.

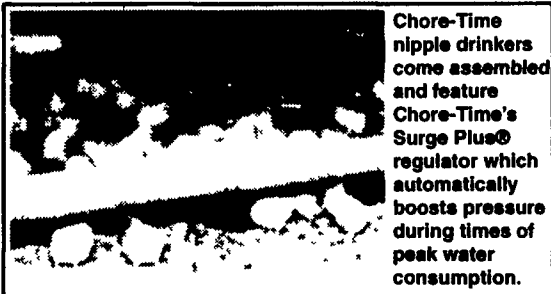

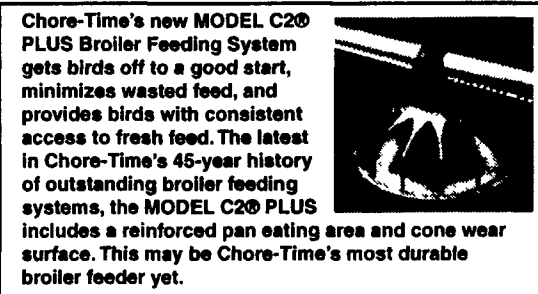

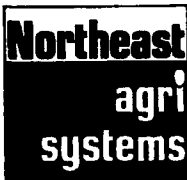
