Proceed 6/10 mile to make right turn onto State Rt. 4007 at auction sign to the first farm on right. Approx. 30 miles West of Harrisburg.

This 130 Ac. farm, located in Juniata Township offers endless potential to the farmer as well as the land developer. This farm consists of approx. 74 acres of tillable land with a shaly, silt loam type soil, known as calvin. This good soil is suitable for most all crops.
