## Pennsylvania Farm Bureau Provides **National Legislative Report**

CAMP HILL (Cumberland Co.) — "Farm Bureau has been involved in a lot of legislative activity in Congress in recent months aimed at helping to save costs and improve net income, both long term and short term, for farmers," said Guy Donaldson, president of the Pennsylvania Farm Bureau. "Here's a report on some of the major issues Farm Bureau has been working on."

Crop Insurance/ Farm Assistance

President Clinton signed legislation H.R. 2559 passed by Congress to spend \$15.2 billion for crop insurance reform and farm assistance. The legislation provides \$8.1 billion for increased premium subsidies, and expansion of crop insurance programs, including revenue insurance for livestock.

Another \$7.1 billion is included for market assistance payments with \$5.5 billion going to Agricultural Marketing Transition Assistance (AMTA) and \$1.64 billion in payments for minor crops.

The legislation provides \$5.1 million for loss of income to fruit producers whose orchards must be destroyed because of Plum Pox Virus infection.

**Permanent Normal Trade Relations For China Passes House** 

The U.S. House of Representatives passed legislation granting Permanent Normal Trade Relations (PNTR) for China by a larger margin than expected.

The U.S. Senate agreed to consider the legislation and act on its passage without amendments. This action will avoid the need for the legislation to go to conference, and will allow it to go directly to the President upon U.S. Senate passage.

However, Senate Majority Leader Trent Lott (R.-Miss.) is withholding Senate action on PNTR for China. The speculation is that the Senate Majority Leader is holding the PNTR vote as a bargaining chip to gain more cooperation with the administration in passing appropriation bills.

The Senate is expected to pass the legislation by a wide margin. Sen. Rick Santorum (R.-Pa) favors PNTR for China, while Sen. Arlen Specter (R.-Pa.) opposes it.

**Estate Tax Eliminated** 

The House passed The Death Tax Elimination Act (H.R. 8) with a near veto-proof vote (279-136). The House-approved legislation repeals death taxes by the year 2010. The legislation retains assets (up to \$5.6 million) on a stepped-up basis when the tax is repealed in 2010.

The stepped-up amount would be indexed to increase automatically with the inflation rate. All estate sizes would retain stepped-up basis assets of \$1.3 million. If an estate were larger than \$1.3 million, the heirs could choose which assets retain the stepped-up basis. There would be an additional \$3 million of assets eligible for stepped-up basis on estates transfers between spouses, bringing the total value of stepped-up basis assets in such transfers up to \$4.3 million.

The legislation also reduces all estate tax rates by about 15 percent over 10 years and lowers the bottom effective rate from 37 percent to 18 percent. The top

rate is cut from 55 percent to 53 percent in 2001 and to 50 percent in 2002. All rates are reduced by one percent in 2003-2006 by 1.5 percent in 2007, and by two percent in 2008-2009. The unified credit is changed to an exemption in 2001 which lowers the bottom estate tax rate from 37 percent to 18 percent.

Pennsylvania's Congressional Delegation vote on the legislation split along party lines with Republicans favoring and Democrats opposing the legislation. Most Democrats are supportive of alternative legislation that would address elimination of estate taxes for family-owned businesses. The Senate is expected to act on estate tax elimination after the July 4 recess. Passage is questionable, and the Senate legislation is expected to mirror the House version. Sen. Santorum supports estate tax elimination, while Sen. Specter is undecided. President Clinton has threatened to veto the House passed measure.

**Agriculture Appropriations** 

U.S. Representative George R. Nethercutt, Jr. (R-Wash.) has proposed an amendment that would lift sanctions on agricultural and medical exports to Libya, North Korea,

Sudan, and Cuba. However, the amendment would allow the President to reimpose the sanction with both the House and Senate approval.

Lacking sufficient support to defeat the sanction's amendment in the House agricultural appropriations bill (H.R. 4461), House leadership delayed voting on the measure. A similar sanction amendment passed the Senate Appropriations Committee and was included in the Senate agricultural appropriations bill (S. 2536). Sen Lott will not allow the Senate to act on the agricultural appropriations bill until the House acts.

The estimated value of agricultural imports by these five currently sanctioned countries is \$7 billion. If sanctions are lifted, U.S. agricultural exports are expected to increase for rice, wheat, corn, soybeans, feed grains, milk powder, animal products, fruits, and vegetables. Other Issues

The Veterans Administration Housing and Urban Development (VA HUD) appropriations bill contains language to delay the Environmental Protection Agency (EPA) from implementing its proposed Total Maximum Daily Load (TMDL)

changes for a year. The language prohibits EPA from spending funds to finalize or implements the TMDL rule. The House has passed (256-169) the VA HUD and Independent Agencies Appropriations bill (H.R. 4635). The proposed TMDL changes would mean more regulatory compliance costs for farmers and owners of forest lands.

The Health and Human Services (HHS) appropriations bill stops the Occupational Safety and Health Administration (OSHA) from implementing ergonomics regulations. The Senate passed the bill on a party-line vote with Democrats, joined by Sen. Specter, opposing it. The ergonomics proposal could affect many agricultural workplaces.

Rep. Richard Pombo (R.-Calif.) has introduced H.R. 4548, his long-awaited reform bill dealing with migrant labor. This legislation creates a new migrant labor program alongside the existing program to demonstrate the value of Farm Bureau-supported reforms.

"We will continue to work for implementation of our organization's policy goals on these issues," said Donaldson.
