

of Ludwigshafen, Germany, taking over the Cyanamid agricultural products business of American Home Products Corporation (AHP), a company headquartered in Madison, N.J.

This purchase, the largest acquisition in the corporation's history, doubles BASF's crop protection products business and moves it up into the ranks of the world's top three leading manufacturers of crop protection.

BASF's crop protection sales amounted to U.S. \$1.9 billion in 1999. This closure follows approval of the EU Commission. Earlier in June, the waiting period under the Hart-Scott-Rodino pre-merger notification statute expired without any action by the U.S. antitrust agencies.

Since signing the agreement at the end of March, BASF has moved ahead quickly in planning of the integration, to be ready for the important fall launches in the northern hemisphere.
