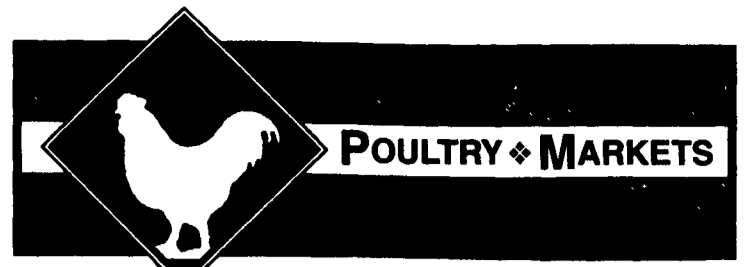

In Philadelphia, all prices were unchanged to 1 cent higher. In new england, prices were 2 cents lower on large and unchanged on the remainder of sizes. In Boston, prices were unchanged. The market tone was steady to fully steady on white eggs and steady to barely steady for brown eggs. demand ranged moderate to good, better into feature activity. Supplies were generally adequate on all sizes. The New England shell egg inventory was 3 percent less, more than last Monday. Breaking stock offerings were adequate to fully adequate for the moderate demand. Light type hens were adequate to ample for current needs.

EASTERN REGION FROZEN EGGS, JULY 21, 2000. FEDERAL-STATE

Majority prices were unchanged on whites, balance of items were unchanged to slightly higher when compared to a week earlier. Demand was fair but not active for immediate movement and improved for future shipments. Supplies were irregular, but sellers were showing a little more confidence. Undertone was improved and usually reported as fully steady. Liquid and frozen eggs (ingredients included) processed under federal inspection in the Eastern region for the week ending July 15, 2000 were 14 % more than last week, and 9 % more than a year ago.
