programs, forums and professional journal articles are all, provided for these groups to utilize.


The Center also serves as a key source of information for federal, state and local government officials when important agricultural issues arise. Educational materials, in-service training, programs and general information are offered for extension faculty and staff to use. The Center provides a wide range of additional information services. It maintains a current extensive listing of publications on issues such as the PA Nutrient Management Act, Right to Farm Law, Agricultural Nuisance, Alternative Dispute Resolution and many other

pertinent topics. All of the Center's publications are available free of charge on their web site at www.dsl.edu/aglaw/aglaw.html or a hard copy can be purchased at the cost of copying. Other services include research on current and emerging issues in international agricultural business and professional-level courses focused on agriculture law.

When key issues arise in the agriculture industry, the Center responds accordingly to help aid in ag law education. Currently the Čenter is working with Penn Ag Industries and the State Conservation Commission to provide educational seminars for Conservation Districts on the Nutrient Management Act and their responsibilities. The Center is also working with the Pennsylvania Department of Agriculture on a handbook on dispute resolution in response to Senate Resolution 91.

Although the Center does not provide legal advice, nor is it intended to be a substitute for legal advice, it will provide extensive information regarding a legal issue, which may help avoid legal disputes or aid in resolving them. Any inquires on topics that are not already available in a publication will be researched by the Center and responded to free of charge. With the combined resources of law school faculty, staff, students and the library, the Center is a valuable source for information regarding agricultural law.
