## SNYDER ESTATE SALE

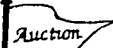

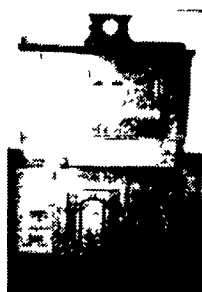
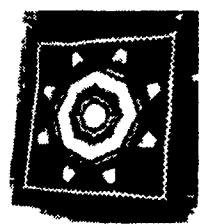
