## USDA To Review Some Pork **Checkoff Referendum Ballots**

Department of Agriculture announced recently that ballots cast in the pork checkoff referendum that were declared invalid will be reviewed to determine whether they can be counted as valid ballots.

Farm Service Agency (FSA) county offices reported that, of the approximately 30,000 ballots cast, more than 2,000 ballots were declared invalid because certain required information was missing.

Such missing information on registration and certification forms included the person's address and the date the form was signed. The missing information was for administrative needs, in-

FSA county offices are being directed to review the registration and certification forms for ballots previously determined to be invalid. Based on the new instructions, FSA county offices will count and report the results of their review. USDA expects to announce the results of the vote by the first week of January 2001.

The public may witness the review and counting of previously declared invalid ballots but may not interfere with the process. Not all counties in each state had invalid ballots, so interested persons should contact FSA county offices for information.


