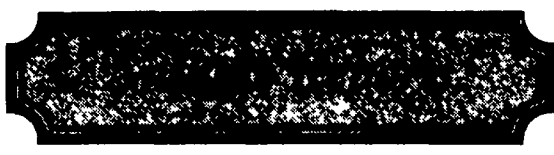
ROHRER AND KREIDER SALE

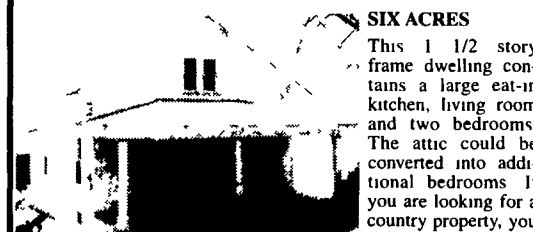
