



Theorem Paintings Unique American Folk Art

Chances are you've seen theorem paintings at antique shows and wondered what they were. These highly stylized still life paintings, usually of baskets of fruit and flowers, at first glance are reminiscent of the decorative motifs found on the backs of early Hitchcock chairs. And well they might be.

The Hitchcock chair designs from 1820 to 1830 used the same stenciling techniques. During the time the stencils, were cut from many pieces and put together in different arrangements. Later a single stencil was used on Hitchcock chairs.

The most common theorem paintings are of baskets of fruit and flowers, but some very intricate theorems depicted landscapes and portraits. The landscapes show a separation of the different parts, put together to form a single subject such as a house or tree. Sometimes a freehand painting completed the painting.

The word "theorem" means stencil. Stencils have been used to decorate everything from 19th century hatboxes to floors, linens and walls. However, it is the still life theorem paintings that were hung on walls, instead of conventional paintings that collectors of Americana look for. When they come to auction, prices can range from \$800 to more than \$8,000. Recently, several velvet painted theorems were sold at auction for more than \$800 each. Most were unsigned.

The earliest known types of theorems were painted on furniture in the 17th century by Dutch settlers in the Hudson Valley. They used a technique known as Grisaille — a gray wash. Grisaille still life paintings were done on paper in shades of gray. Because of their fragility they are scarce and costly. In part because they were difficult to make. Unlike the later colorful theorems, Grisaille have a very primitive quality

In America, theorem paintings seem to have originated in New England. Many of the paintings were cut from heavy paper and done by housewives and young women in academies. For the velvet theorems a firm, white cotton velvet was stretched and prepared like a canvas.

Theorems on velvet were popular from 1800 to the 1860s. Until recently, they were unpopular with collectors who associated them with the tacky velvet paintings sold to tourists in the 1960s-1970s. They still sell for half of the price for watercolor theorems. The more complex and unusual the design the higher the

The stencil designs were carefully arranged then filled in with watercolors or oils. Other times, depending on the talent of the artist, the stencils were done freehand from instruction books.


