In Philadelphia and Boston, prices were unchanged to two cents lower on the larger sizes and unchanged on mediums. Prices paid to producers in New England were two cents lower for extra large and large, unchanged on the remainder of sizes. The market tone was reported as soft and ranged barely steady to weak. Demand was light to moderate, best where features were in progress. In the Philadelphia vicinity, large eggs were advertised for 59 cents per dozen with no restrictions. Supplies were adequate to available. Breaking stock offerings were fully adequate to ample for the light to moderate demand. Light type hens were fully adequate for normal processing requirements.

Processing schedules were moderate to moderately heavy. Less than trucklot asking prices were unchanged at 56 to 70 cents. Trade sentiment was mostly steady. In the parts complex, all items were generally noted as in balance or adequate for the light to fair and selective buying interest

Trade sentiment was unsettled but about steady on whites, balance of items were generally steady to fully steady. Liquid and frozen eggs (ingredients included)

processed under federal inspection in the Eastern region for the week ending July 28, 2001 were 2% more than the previous week, and 2% more than a year ago.

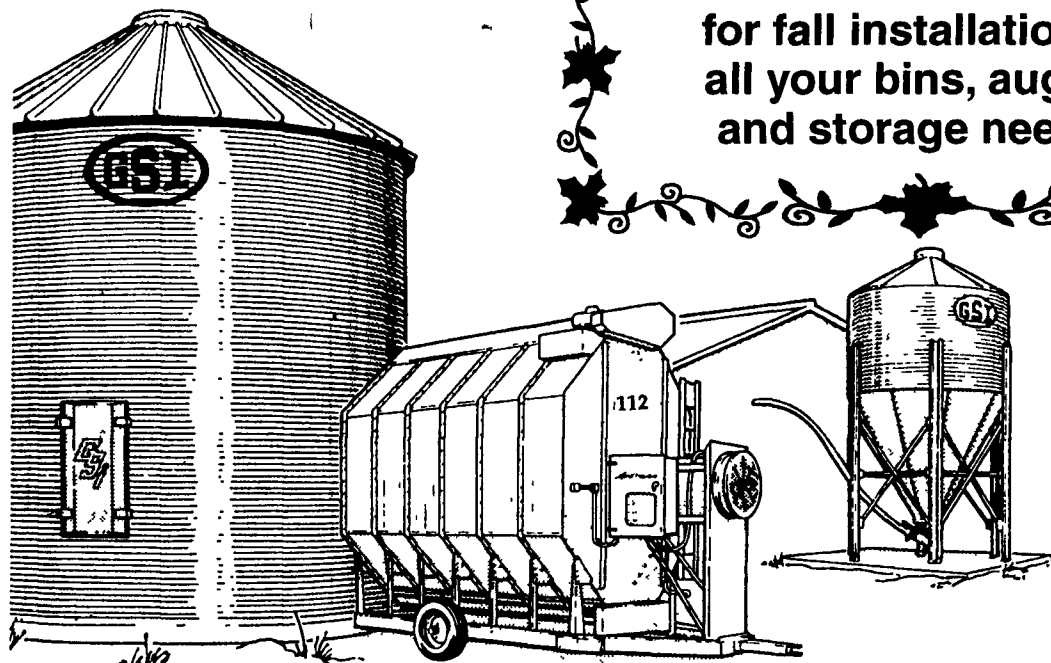
