New this year will be a list of news Websites carrying information important to agriculture, beside updates on the previous edition. Also included in the

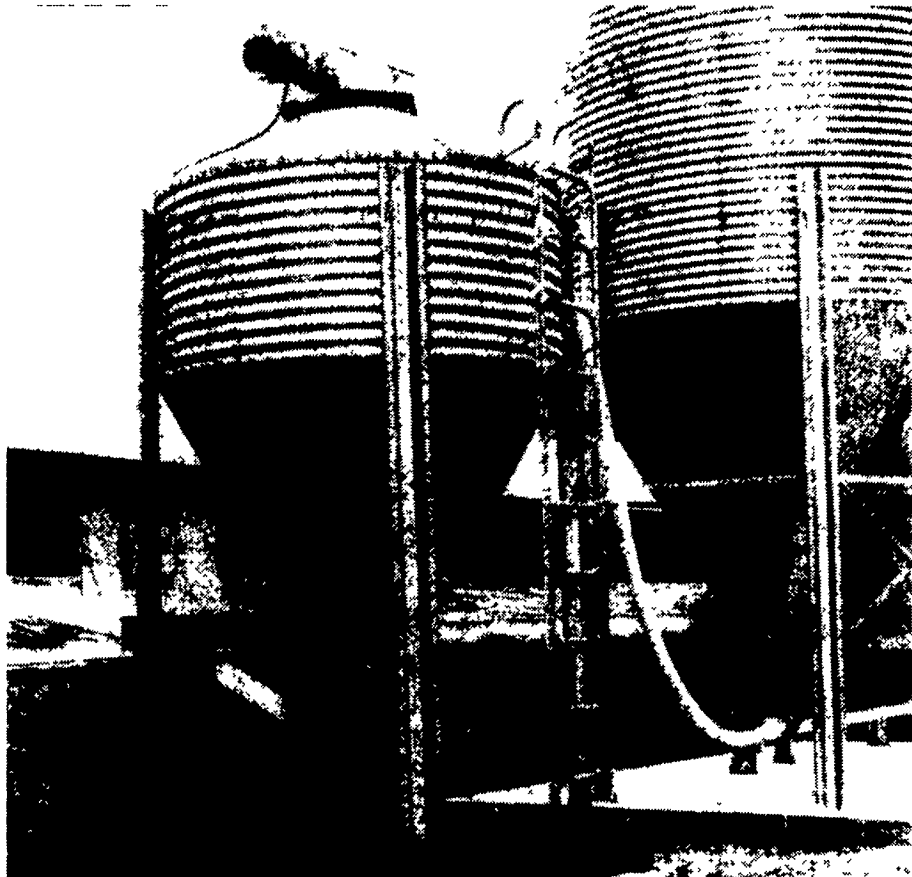
latest edition will be expanded university and government contact information.

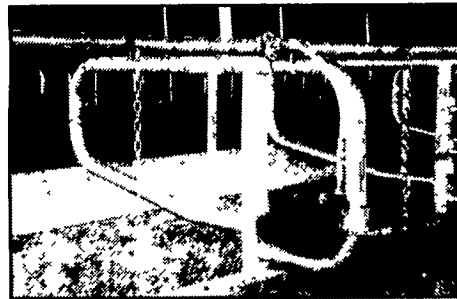

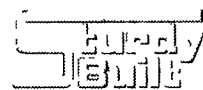
