The market tone remained fully steady to instances firm on bone-in breasts, fully steady on boneless-skinless breasts, cautiously steady on wings and barely steady to weak on leg quarters.

Demand and trading limited. Trading and demand for bulk parts and meats slow. Buyers taking a wait and see attitude.

EXPORT MARKET HIGHLIGHTS: Demand and trading was light. Most buyers cautious as the market becomes unsettled due to recent actions in the export arena.

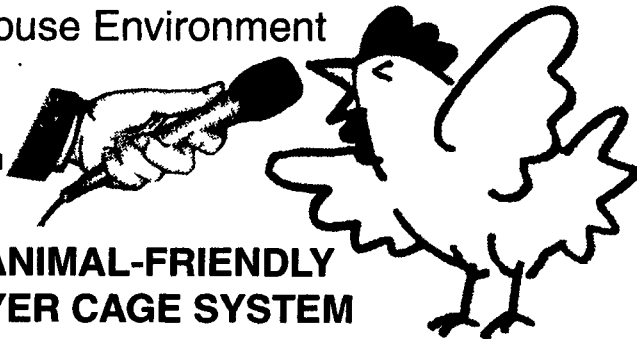
Movement of ready-to-cook whole birds was usually noted as fair or decent for the mid-part of the week. Seller offerings were fully adequate to ample and generally more readily available on the 2.5 pound size. Live supplies were mostly moderate; weights were mixed in a range of light to heavy. Processing schedules were moderate. Less than trucklot asking prices were unchanged at 49 to 63 cents. Trade sentiment remained about steady. Breast items cleared well, especially bone-in breasts. Leg cuts, particularly leg quarters were ample and competitively priced in an effort to stimulate buying interest. Wings were ample.

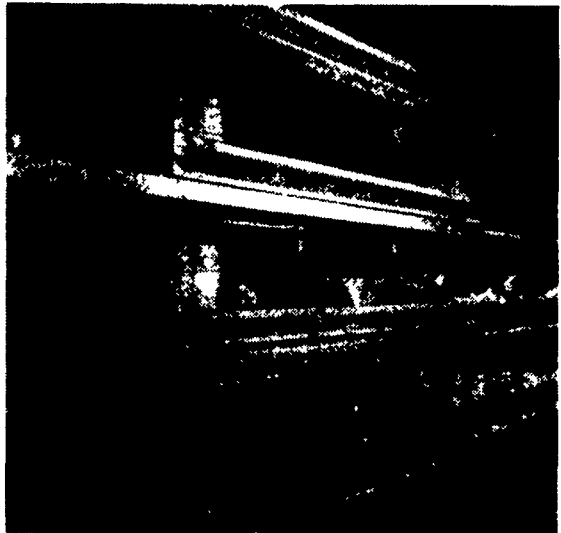
