USDA Market News USDA Carlot Meat 4:00 Summary: Compared to Previous Day, Prices in Dollars per hundred-weight, Equated to FOB Omaha Basis.

**BOXED BEEF CUTS:** Boxed beef cut-out values lower on moderate demand and moderate to heavy offerings. Select and Choice rib, chuck, round and loin lower. Beef trimmings generally steady on moderate demand and offerings.

Estimated composite cutout value of Choice 1-3, 600-750 lbs carcasses down 1.81 at 109.36, 750-900 lbs down 1.48 at 109.15; Select 1-3, 600-750 lbs down 1.08 at 105.54, 750-900 lbs down 1.34 at 104.82; based on 140.30 loads of Choice cuts, 164.78 loads of Select cuts, 58.23 loads of trimmings, and 85.21 loads of coarse ground trimmings.

Estimated carcass price equivalent value of Choice 1-3, 600-750 lbs down 1.08 at 98.21, 750-900 lbs down .84 at 98.06; Select 1-3, 600-750 lbs down .72 at 92.45, 750-900 lbs down .89 at 91.97. Current index reflects the equivalent of 312,226 head of cattle.

**NATIONAL CARLOT BEEF:** The Cutter cow carcass gross cutout value was estimated at 86.44, unchanged.

By-Product Drop Value: Hide and offal from a typical slaughter steer was estimated at 7.35, up .01.

**NATIONAL CARLOT PORK:** Sales reported on 55.0 loads of pork cuts and 12.0 loads of trim/process pork. Compared to Monday's close: Fresh bone-in loins 2.00 higher; butts 3.00-4.00 lower; skinned hams 20-27 lbs steady to firm; seedless bellies 14-16 lbs 3.00 higher; lean trimmings steady. Trading slow to moderate, with light to moderate demand and offerings.

WASHINGTON, D.C., July 5 — (USDA-NASS) — Total red meat production under federal inspection for the week ending Saturday, July 6, was estimated at 763.1 million lbs., according to the USDA's Agricultural Marketing Service. This was 17.8% lower than a week ago and 4.3% higher than a year ago. Cumulative meat production for the year to date was 3.1% higher compared to the previous year.

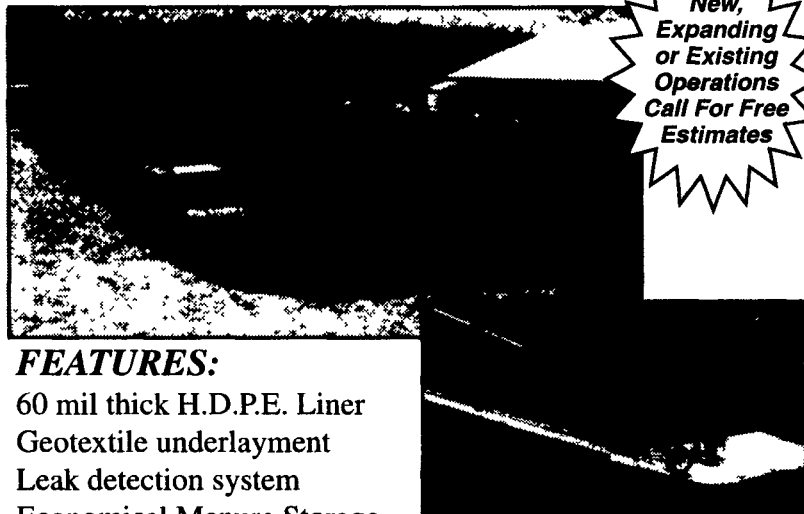
