Mostly prices were unchanged to slightly lower on salt yolk and the balance of items were mostly unchanged when compared to last week's trading. Trade sentiment was irregular, but generally improved. Demand was light, however movement was still fairly active. Supplies were sufficient on most items. Liquid and frozen eggs (ingredients included) processed under federal inspection in the Eastern region for the week ending July 27 were 4% less than the previous week, and 5% lower than a year ago.
