
New York Eggs ATLANTA, GA. September 4, 2002 **Report Supplied By USDA**

Prices advanced 2 cents on mediums and were unchanged on extra large and large. The market tone was fully steady on mediums and steady at best on heavier weights. Demand was moderate to occasionally good especially where features were in place. Some advertised prices on 1 dozen extra large eggs were at 59 cents and 62 cents, and also 89 cents with a store card. The New York shell egg inventory decreased 8 percent and the New Jersey inventory was about unchanged when compared to last week. Supplies were adequate for current needs.



Prices paid to producers in New England were two cents higher on mediums and unchanged on the balance of sizes. In Boston, prices were unchanged. The market tone was steady to fully steady with mediums in the strongest position. Demand into all channels remained light to moderate, best where featured. In the Philadelphia area, large eggs were advertised for 88 cents per dozen. Supplies of all sizes were adequate to available. Breaking stock offerings were sufficient for the light to moderate demand. Light type fowl were fully adequate.


