G.B. Gunlogson Environmental Design Student Competition, which was conducted July 30 in Las Vegas, comprised two options.

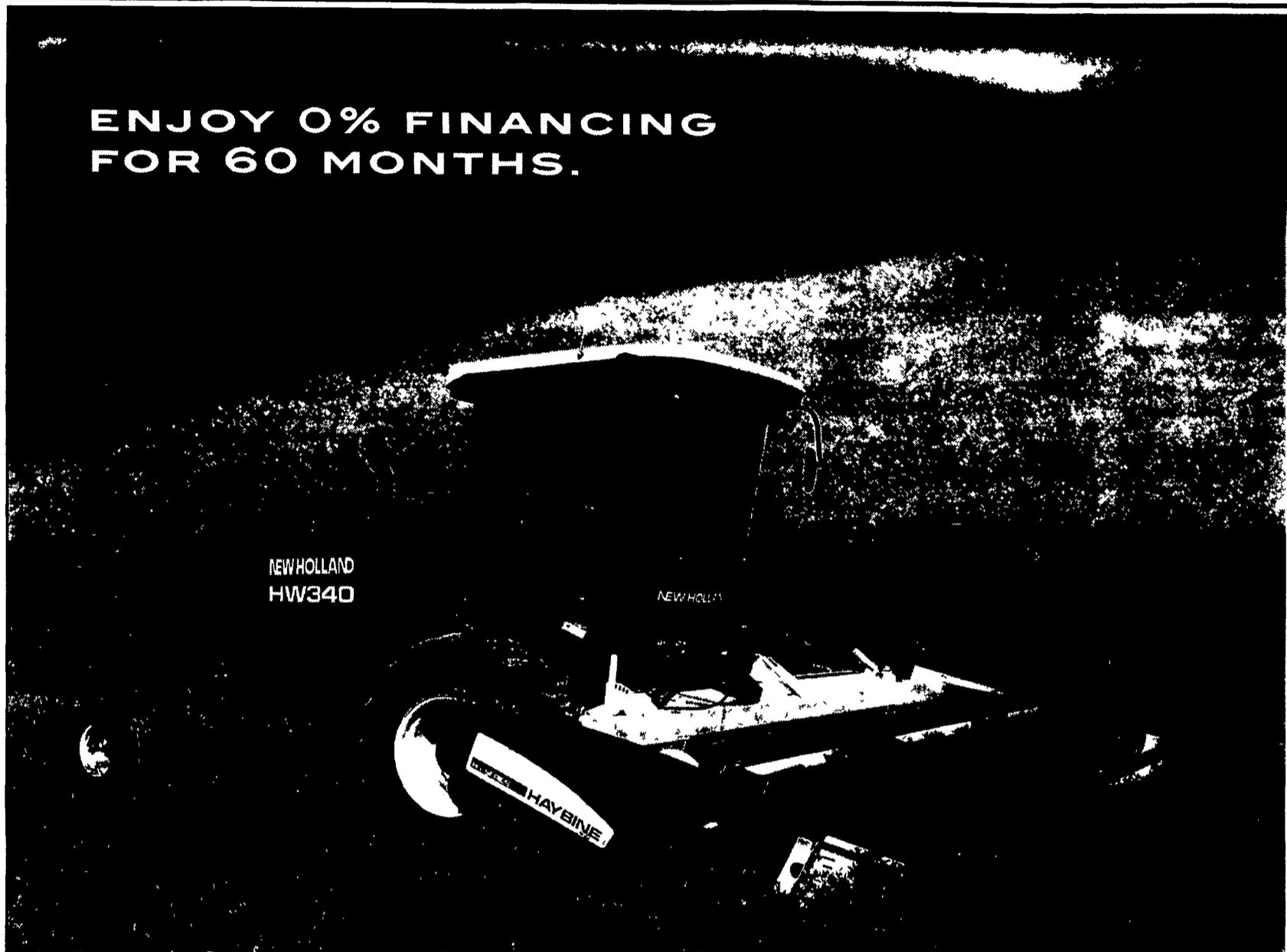
The first, Treatment System

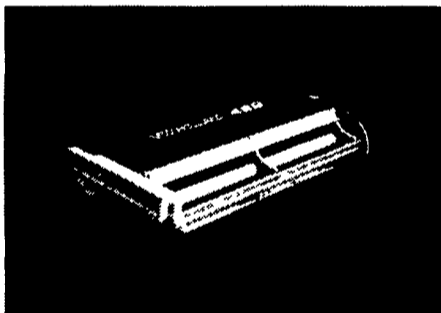
Duffy, Ryan Stokes, and Brian Henslee, of The Ohio State University.
