Resolution Proposing Amendments to the Constitution OF THE COMMONWEALTH.

SECTION 1. Resolved by the Senate and House of Representatives of the Commonwealth of Pennsylva-nia in General Assembly met, That the following amendments be and the same are hereby proposed to the Constitution of the Commonwealth, under and in accordance with the provisions of the tenth article . thereof, to wit :

PROPOSITION 1, TO BE ARTICLE XI. SECTION 1. The aggregate amount of debts hereaf-ter contracted by the Commonwealth shall never ex-ceed the sum of five hundred thousand dollars, except

in case of war to repel invasion, suppress insurrec-tion, or to redeem the public debt of the Common-wealth, and the money so raised shall be applied to the purpose for which the debt may be contracted, or

the same may be required to pay the interest of said debts semi-annually to reduce the principle thereof by a sum not less than five bundred thousand dollars, increased yearly by compounding at a rate of not less than five per centum per annum; the said sinking ierd shall be invested in the Commonwealth, which shall be cancelled from time to time in a manner to be provided by law: no portion of the sinking fund shall ever be applied to the payment of the debt of five hundred thousand dollars mentioned in the first section of this article, but the said sinking fund shall ings.


