RAINSBURG BOROUGH LAWS.

Section 1. From and after the 15th of April next no person or persons shall be allowed to block up any streets or side-walks of the Borough of Rainsburg, with wood or other matter of incumbrance.

2. No shooting of mark, throwing of fire-balls, fire rockets, firing of squibs, nor other kind of fire-works will be allowed in said Borough.

3. Public houses, taverns, and other places where liquors are sold, shall be kept in a neat and clean manner. Also a fine of three dollars for running horses through the streets.

4. No person or persons to exhibit any kind of Managerie or show of any kind without first having paid a tax of three dollars for the use of said Borough for each time of Exhibition.

5. It is a tax of two dollars on any person keeping any bitch in said Borough, and any family keeping more than one dog shall pay a tax of fifty cents for every dog so kept.

6. Makes it the duty of the Borough officers to see that every citizen be compelled to keep all streets and sidewalks clean and safe from danger by him. All of which said Laws to take effect within ten days from the date hereof, except the first section.
