validity of thote purchafee of which Mr. M. Cleraehan fo confidently pereaks. of duty to the creditors in general to repeat their caution agsint purchafing of thole grateces or either of them, and to extend the terms of it to a purchare from any other perfons (if fuct there be)
to whom Mr. M'Clenachan may have made fimilar
