LONDON, November 16.

The American agents are at this time ve-ry bufy in buying up fhips to be converted into fhips of force ; feveral of the Freuch, Dutch, and Spanifi prizes lately taken, have been purchafed by them, and are, with per-miffion of government, gone into private docks to be repaired, and fitted out with all poffible difpatch.

The Duke of Devonshire and Earl Moi-ra have fet a laudable example in Ireland, by refolving, that they will let no effaces in future to what are termed middle men, but that the real occupiers shall be the only lea-fers of their respective farms.

Lady Nelfon has taken a houfe at Bath, for the reception for her gallant Lord, who is fhortly expected to arrive in England.

Letters from Hamburgh fay, that Du-mourier, with feveral officers who have fee ved under him have been induced, by advantageous offers, to enter into the fervice of the Ottoman Porte. It is added, that Dumourier and fuite are upon the ere of taking their departure for Conftantinople.

The remittances to this country from the Continent have of late been fo gr at, that there is at this moment more cash in the Bank, than there has been at any period fince the commencement of the war.

The price of Salt Petre has lately advanced near bo per cent. Several articles of drugs are also increased lately beyond all precedent.

Yefterday arrived in town feveral of the Officers who came over in the late cartel fhip from France. They report that the French government are in a flate of the utmo alarm, in confequence of the tumults which have broken out in the Netherlands, and



the charge. He then read a kind of Defer ing which he was at three different inflammatory paffage ftopped by the Court, and fuffered to erafe the obnoxious parts out of the Paper. The general tendency of this paper 'was that he confeffed having entered into the French fervice (and he produced his commif-tion of Chief de Brigade); that he had em-barked in the great defign of raifing three millions of his own fellow fubjects from a flate of bondage; that he had made the fame attempt in which Walhington had fuc-ceeded, and Kofciusko had failed; to the Catholics of Ireland he acknowledged his obligations; he had engaged fiscerely in their fervice, and had been amply remunera-ted; the connection of Ireland with Great Britain he had ever confidered as her bane, and he had acted under that conviction to rescue his country; fucces he could not command, and he was prepared to meet his fate.

As a foldier, however, he wished to die like a soldier; he wished as an emigrant taken in arms, to be treated as the French had treated the Count de Sombitieul, and to be fast; the fooner his fate was to take place, the better; he wifhed it might be within an hour.

He was then remanded to prifos, and the Court proceeded to difculs the fentence, which was fent to the Lord Lieutenant for his approbation, and has not yet transpired.
