The final downfall of the Regicidal Republic of France, that event which all men of sense felt to be necessary and saw to be inevitable, hath just been compressed in the most complete and satisfactory manner, by agents the most desirable, by means the most effectual, and in a manner the most instructive and exemplary.

With the return of its lawful and only natural government to France, all these distempered and incoherent phantasms of liberty, equality, and perfectibility, universal republicanism, and universal domination, disappear, like the retiring mists of a morning in Spring before the orient sun.

A poor, ignorant, beastly German, of the name of Meyer, the printer of a Republican Gazette in York County, asserts that a meeting has been held there, for the purpose of denouncing against me a number of delicate Democratic anathemas.

There has been much talk of late respecting a defection of the subscribers to the Aurora, said to have been occasioned by some testimonials of disrespect exhibited by the people who manage that paper, towards the memory of the late General Washington.

Now, it is not very probable, nay, from the nature of the case, it is very improbable, that the first of these classes could be incited to forego their amusements on such an account; and, as to the last, we well know that they have stood many feverish tests of their fidelity to the cause of plunder and murder than any to which they have been recently subjected.

Extract of a letter from New York, dated January 21. "The sloop Lucky, Franklin, of Philadelphia, has just arrived from St. Sebastian. Capt. F. informs that about the 30th of October, the ship Woodrop Sims, Hodgdon, of Philadelphia, was captured by the French privateer Heureux, mounting 22 French 12's and 230 men, after a very gallant and well fought action, which continued from half past 10, A. M. till 2 P. M.

At 11, A. M. several of the Woodrop's guns were dimounted, but thro' the bravery of her crew, they were removed, and were obliged to cut away the after trucks to prevent a similar accident. The 2d lieutenant and 2 men were killed, and 3 wounded on board the Woodrop Sims. The French had 2 killed, and 4 or 5 wounded."

HALIFAX, (N. C.) Dec. 19. Extract of a letter from Raleigh, dated December 19. "Our legislature is truly federal, and evince it from their appointments. The Jacobins "had not the effrontery" to offer a democratic candidate for Governor, and all those they have offered for militia officers have failed to succeed.

The two Carolinas will in future, I hope, understand each other, and unite their influence and efforts to frustrate that spirit of domination, which Virginia seems so anxious to extend. Reflecting men have seen its progress for many years; but it is only lately that it has become obvious to all—it is in other words, a spirit of rivalry and insubordination, totally incompatible with the nature of our government.

There came a lady in a carriage (but not her own) to Black-Swamp, to the house of Mr. William Lawton, far advanced in pregnancy, and was delivered the same night. In a week or two after, the child died, and she removed to a near neighbour of Mr. Lawton, where she was taken very ill, with a fever & ague, and there died on the first day of this month. She was handsome and genteel, very polite, and said she had a great education; that her father was a wealthy gentleman; that he had married against the consent of her parents, to a merchant, who since had broke, and had failed since in a ship as mate; but she never mentioned, either the ship's name, or whereunto bound. She called herself Lucy Gratton, and said that her father lived near Georgetown. She had a great quantity of very good clothing; and it is said, she had, and had left a sum of money. She said she wanted to go to Augusta; but, there is no certainty from whence she came, nor whether she told her real name.
