of health and prosperity which have attended their institution during the past year, and they rejoice to state that there has not been one case of sickness in that period requiring the advice of their physician.

The amount received for children's board from the lat day of January until the Sist day of December, 1865, was \$3046, while the expenses during the same period amounted to \$5201.79. There were admitted to the Home during the

year 1865, in all sixty-five children, and there remained upon the 1st of January, 1866, sixty-three children, viz., twenty boys and forty-three pirls, many of whom are the offspring of our brave soldiers.


