RESISTANCE TO OFFICERS .- On Thursday hest Deputy United States Marshal Sharkey, in company with a Special Deputy of the Circuit Court of the United States, proceeded to a place called Peanock's Mill, about four miles distant from West Grove Station, on the Philadelphia and Baltimere Central Baltonic. and Baltimore Central Radroad. These Deputy Marshals had writs of injunction and of sub pona placed in their hands to serve upon parties having a factory at Pennock's Mill, where they manufactured hard rubber combs, etc., in intringement upon the Nelson Goodyear patent The factory was entered by the Marshals, and service of process made, though violent resistance and unprovoked assault was made upon them, both before, during, and after the service, by some ten workmen inside. The Marshals were expected, with violent attacks, from the building, and followed upon the road leading from the place and beaten, and were in danger of serious bodily harm. They took refuge in a house in the neighborhood, and atter some delay were enabled to sately take the train for this city.

Upon the hearing of the patent case of Goodyear et al., vs. Mullee et al , attidavits were sub mitted to Judge Grier, stating the facts above related, and Judge Grier granted injunctions in the case against the intringers, and directed United States District Attorney Gilpin to have the parties brought before United States Com-missioner Aubrey H. Smith, on criminal pro-cess, for violent resistance to the officers of the Court.

Colonel P. C. Ellmaker, United States Marshal, in company with his deputies, Messrs, Snarkey, Schuyler, and Waram, and a detachment of eight of the Twenty-fourth Ward Police, under Sergeant Saunders, ou Saturday last proceeded to the factory of the infringers to arrest the parties charged with beating the officers on Thursday. The factory was reached, being ap-proached by the Marshal's posse in two squads, and surrounded before the parties inside were ap prised of the proximity of their visitants.

The Marshal rapped at their door and de-manded admittance, stating his office and authority to enter. Those inside the factory denied his admittance, and used words of de-fiance, contempt, and menace towards him. After a short parley the Marshal ordered the door to be broken in, which order was being complied with, when two men came out by another passage at the side of the building They were taken into custody, when they called to those inside not to open the door. The Mar-shal expostulated with them to advise their friends to come out; they declined to accede to his wish, and the door was again attempted to be forced. At this juncture it was opened by those inside, two or three of whom appeared at the slight opening of the door, armed, and ap-

parently in the act of ming. kept cleared by this deperate menace but for a moment, when one of the men came out, revolver in hand, and discharged one barrel at the officer nearest him, at the side of the doorway, happily without effect. He was secured and his weapon taken away. Another appeared with a huge hammer, but was without difficulty disarmed, Others came out and were taken into custody. Two were found hidden at the top of the building, under the roof. Nine were thus secured, One of those criminated by the assault and resistance on Thursday was seen to pass on a train for the city, and was arrested at the West Philadelphia depot, notice having been telegeaphed to the station. These desperate men, thus openly delying the law, were brought to this city, and committed by Commissioner Smith on Saturday night for a further hearing this morning.

PROBABLY A MARE'S NEST .-- Upon information volunteered to the detectives that a person was in the city who was strongly suspected of being the burglar at White's Dentai Depot, in Arch street, in October last, when Needs, the colored porter, was killed a man who gives the name of Daniel Foley was before Alderman Beitler on Saturday last. DEATH OF ROBERT STOCKTON JOHNSON.-Another of our citizens of sterling worth, Mr. Robert S. Johnson, died on Saturday, of preu-monia, at the advanced age of seventy-six years. He was a native of this city, ason of one of the most distinguished lawyers of New Jersey, whose portrait still decorates one of the court houses of that State. Mr. Johnson was many years successfully engaged as a merchant and manufacturer in the iron business. He devoted the later years of his life to the pursuit of agriculture as a science, and we know of no one who has done more to stimulate the famers in the vicinity of our city, especially in New Jersey, to a generous rivalry in the development of the re-sources of the soil. Mr. Johnson was a gentle-man of much urbanity, unosteniatious berevoence, and unswerving correctness in all the relations of life. He was, in a word, an honest man-the noblest work of God. The flags of the ferry-boats were at half-mast on Saturday out of respect to his memory.

ASSAULTING COLORED WOMEN .- The Recorder had before him, on Saturday afternoon, a man named William Taylor, conductor, and George Palmer, brakesman, on the West Chester Railroad, on the charge of assault and battery upon two colored women, named Mary E. Mile and Annie Adams. It appears that on Saturday week the plaintiffs took passage in the 7.30 A. M. traip of the West Chester Railroad, taking seats in the rear end of the passenger cars. Shortly alter, the conductor, Mr. Taylor, can along and said, "You had better go to the front part of the car." Mrs. Miles refused to comply with the request. It is alleged that the conductor seized hold of Mrs. Miles, calling to his assistance the brakesman, who likewise seized hold of Miss Adams, and they were together violently ejected from the cars. Taylor and Palmer were held in \$1000 bail each for trial.

RUNAWAY AND ACCIDENT .- A horse atached to a wagon ran away about eleven clock yesterday morning, in the neighborhood Broad street and Passyunk road. Mr. John Frazier, the occupant of the vehicle, was thrown out and severely injured. He was picked up in an usensible condition and taken to a house in the vicinity, and afterwards to his residence, at Eleventh and Market streets.

SLIGHT FIBES .- The alarm of fire at 7:30 A. M. yesterday came from a house on Twenty-third street, below Spruce. A subsequent one, at quarter to 3 o'clock, came from No. 1823 Shippen street. In both cases the damage was trivial.

BADLY INJURED .- On Saturday evening about 9 o'clock a German named Adolph Bud-hart, residing at No. 1422 Vine street, was badly injured by being run over by a wagon at Eighth and Noble streets.



In answer to a question, Boyer told the Alder-man that he and Kelly and Foley had been to-gether on Friday to a drinking house on Race street, and had a game of cards there, and that Boyer and another of the company got into a quarrel, which ended in a light; that he (witness) interfered, and the result was that he and Kelly were arrested; Boyer also. He admitted that it was not till after his own arrest that he mentioned anything of the gold plate and the two sets of teeth having been offered for sale to him by Foley. Being again questioned as to the character of his own house, he admitted that it

is a place of ill-lame. Johnson Kelly testified that he boards at No. 225 Acorn alley, with his wite. He was married by an alderman in Tenth street, near Poplar. If the divide the house is one of bad repute, as Bover, the proprietor, had sworn to. Kelly testified further that he was at Boyer's house when Foley came there and offered to sell the mild plate and showed the sets of test. gold plate, and showed two sets of teeth. He was questioned in respect to the doings of himself, Foley, and Boyer on Friday.

Mary Boyer, wife of Cornelius, testified that she remembered Foley coming to the house while Boyer was absent, and offering to sell a gold plate. Boyer had s sorn that he was present at the time. She testified, in addition, that Foley often came to the house and had offered to sell gold com.

The Alderman decided, under the circumstances, to commit the witnesses, as well as the accused, for a further hearing a week hence. The prisoner informed our reporter that he had been tending bar lately at No. 145 South Fourth street, a respectable ale-house, and that he is married, and leads an honest life. To the Alder-man he stoutly denies any knowledge of what Boyer swore, and claims the ability to account for his whereabouts for two years past.
