A CORPORATION HAS NO LIEN ON THE STOCK OF A DESTOR FOR A DEED DUR BY HIM, UNLESS IT IS GIVEN BY STATUTORY AUTHORITY.

t is clear that there is no lien at common law on It is clear that there is no lien at common law on stock for debts in favor of the corporation issuing the stock. Ang & Ames on Corp., section 355, and authorities there rejerred to It is obvious that a different rule would snovert the wholesome doctrine of the common law against secret liens. When such a lien exists, it is by statutory authority, either extressed in the set of incorporation, or by by-laws made by authority of the set. It is so by soveral sense in that State for instance in the general bank set of 1850, section 10; also in the general caunl and indrons act of 1850, section 7; and in the turnpike bridge, and plank road act of 1853, section 8, and perhaps in some special instances.

Whether a mere by-law would be sufficient to create a lien on stock for a general banned que the company in case of trading, manufacturing, and other corporations not engaged in loaning money, seems not only to be doubted, but generally denied. Certainly, I think it would not be, unless notice of

But it is not indispensable in this case to decide these questions; for no lien is given by the net incorporating the defendants, nor did they pass any by law to create a lien, supposing they had power, till after the death of the testator. The rights of creditors upon the decedent's estate were fixed then, and by no act of theirs could they be changed. The enactno act of theirs could they be changed.
