LATE NEWS FROM PARIS.

Making a Hero of an Assassin-Terrible Career of a Murderess-She Kills Twenty Men within Four Months-Military Correspondence of the Paris Jouranis.

PARIS, May 15 .- In a recent letter I gave some account of Philippe, the man who is now in continement at Mazas (the Faris Tomba), await-ing his trial for the perpetration of *continea* as-sassinations. The pairons of our melo-dramatic theatres complain that the autoors who cater to their peculiar taste are deficient in imagination. and are continually serving up to them the same old play, with the same old incidents of plot, only rehashed and transposed, with no more than a change of title. So it is with the crimes of real life, as well as those of the mimic scene-there is nothing new under the sun. The wrotch Probst, no doubt, seems to you, in America, the villain; but the Frenchman Philippe far out strips in flagitious crucity the German assassin Philadelphia, and even Philippe himself is but a plagary, so far as the number of his un-fortunate victims is concerned, of a woman who signalized herself in Paris during the rule of the Directory.

One day, at the period mentioned, the proprictor of a furnished hotel in the Rue de l'Universile, appeared before the Minister of Police and informed that functionary that a murder had just been committed in his (the hotel keeper's) house. On the previous evening, he said, a stranger had taken a room, stating his residence to be Melun, and his purpose to spend two or three days in Paris. After ordering his baggage to be carried to his apartment, the new comer went out, giving notice that he was going to the Odeon Theatre and should not return to the hotel until the termination of the performance. Near midnight he reappeared, accompanied by a young and very pretty woman, dressed in male attire, who, he said, was his wife. The next morning, at an early hour, the pretended sposa left the nouse, requesting that her husband might not be disturbed until her return, which would be in about an hour. At noon she was still absent; and hearing nothing stirring in the room occupied by the gentleman from Melun, the andlord began to feel uneasy, and rapped at the stranger's door. Receiving no answer from within, the hotel-keeper sent for a duplicate key to the apartment, upon entering which, the unfortunate man was found lifeless in his bed. A doctor was hastily summoned, who, after a brief examination of the body, declared that death had been produced by a blow on the lofe temple, inflicted by means of a blunt instrument.

It was evident that the assassination had been committed by the woman m male attire, and every effort was made by the police to discover her whereabouts, but ineffectually. A month subsequently, another murder was perpetrated under similar circumstances, except that on this occasion the victim, also a traveller, had gone to his room quite alone. At a later hour, however, an effeminate-looking young man came down stairs, and was let out by the porter of the hotel, who remembered the fact on the following morning, when the crime was discovered. This affair caused great excitement in Paris, and redoubled exertions were made by the police to terret out the mysterious assassin, but still without result Eleven days alterwards a third victim perished in precisely the same manner as the preceding two, and in the course of a few months, no less than twenty men lost their lives by means so exactly identical, that no doubt was entertained that the murderous blows were all inflicted by the same hand.

Stung to the quick, Fouche, the Minister of Police, set all his spies to work, and offered a large reward for the discovery of the author of these unparalleled crimes.

One evening a certain B., a member of the Secret Police, but who had the appearance of a provincial gentleman, was passing through a narrow street of the Cite, when he encountered a handsome, equivoeal-looking youth. B. stopped, turned, and said to himself, "That's a woman in male garb. If it should be she !"

At the same moment the handsome stranger also turned, and smiled encouragingly. "That settles the question," murmured the

delighted spy. "Now, if I manage things cau-tiously, my fortune is made." And, retracing his steps, he accosted the unknown. "I have something very particular to say to and gossip, inventing amusing speeches for soldlers mortally wounded, and seeking funny stories "even in the cannon's mouth." Among the most prominent of these battle-field reporters was one in particular, whom we will call Machin, the representative of a literary journal, and the beau-ideal of the military chroniqueur. He came back in high feather, after the armistice, sport-ing a uniform half civilian and half warlike,

wearing a fatigue cap perched jauntily over his right car, an officer's cleak, and carrying his writing materials in a dilapidated cartridge box, which he boasted of having taken from the body of a dead Austrian soldier. The subject of all bis conversations, for months after the treaty of peace had been signed, was the war in which he had participated. "When we took the vinage of Magenta;" "The morning of the day we attacked Palestro;" "As we marched through the streets of Milan," etc. etc., and the acts of heroism and tremendous adventures to which he had been an eye-witness! Accord-ing to Macbin's own account, not less than eleven Generals had been killed at his side, on different occasions, while he was penning his report of the battle, in the midst of a hall-storm of lead. One of his most triumphant recitals was the story of the conference of Napoleon and Francis Joseph. "We were at Cavriana," said Machin; "the two Emperors had met by appointment in a small house of the village. Not another soul was admitted to this important interview, but, of course, I had taken the necessary precautions to learn what was transpiring, as I had a letter to write that very evening. So I passed the guard, entered the house, and took my station behind a deor which opened into the room where the two Sovereigns were seated. Th conversation commenced, but presently Francis-Joseph paused abruptly, and looked around uneasily. What is the matter ?' inquired Napoleon 111. 'We are not alone,' was the reply, 'some one is concealed behind that door.' 'Oh, don't mind that,' returned the French Commander-in-Chief; 'it is a friend of mine, Machin, who is

taking notes for his paper !'" So, when you find by and by minute details of all that is transpiring in the secret councils of the Austrian, Prussian, and Italian commanders published m full in the Paris journals, you may set it down as a fixed fact that Machin is again in the field.

You know that during several years past a mania for collecting postage stamps of all coun-tries has prevailed to a considerable extent on both sides of the Atlantic. This singular idea is now being superseded here by another scarcely less odd. I refer to the collecting of way seals, representing mottoes and costs-of-arms on let ters. One amateur, having gathered upwards of nine thousand different specimens, some of them very old and rare, recently sold his collection at public auction, realizing by his speculation the handsome sum of 10,000 francs.-N. Y. Times.

On the trial, which took place shortly afterwards, the female assassin alleged, in her de-fense, that she had been ruined by a villain, and had sworn to be revenged upon the entire male sex. This romantic story, however, did not pre-vent her conviction and subsequent death on the scaffold.

Several of the Paris journals announce, with a great flourish of trumpets, that they have en-gaged the services of "able correspondents," whose special duty it will be to chronicle the events of the military campaigns, expected to begin, at any moment, in Italy and on the northern frontiers of Austria. During the four years of the Rebellion many of the war correspondent. attached to American newspapers signalized themselves by their talent and courage, commu-nicating to the public much valuable information, together with some facts, perhaps, which it was not advisable to disclose. In France, letters from the battle-field to the principal Parisian journals were innugurated, for the first time, during the campaign of 1859, and were princi-pally distinguished for their plentiful lack of military details, which, to do the correspondents justice, it was perfectly proper not to write, as the press would not have dared to publish either news of a nature to be useful to the enemy, or


