COUNCILS .- The stated meeting of Councils was held yesterday alternoon. Select Council.-Cyrus Horne, James Rhodes, and Robert M. Foast were elected Directors of Gurard College.

A communication was received from Colonel P. C. Ellmaker, of the Committee of Arrangements for the reception of the State flags, asking

ments for the reception of the State flags, asking Councils to permit the use of the Council Cham-bers for invited guests on the 4th of July. Re-terred to the Special Committee. A communication was received from the Board of Health, asking for a further appropriation of \$20,000, to enable the Board to carry out the measures necessary to guard the city against the approach the cholera. Referred to the Com-muttee on Health. mittee on Health.

Mr. Spering, from the Committee on City Property, reported that notice had been received that the rent of the rooms in the Philadelphia Bank-, now occupied by the Recorder of Deeds, is to be increased from \$1500 to \$3000. The Committee state that no other rooms suitable for the purpose can be obtained, and an ordimance was reported authorizing the Mayor to renew the lease for three years, at \$3000 per annum. Agreed to.

The Committee on Bailroads reported an ordi-nance authorizing the Thirtsenth and Fifteenth Streets Railroad Company to extend their road from Thirteenth and Columbia avenue to D amond street; upon Diamond street from Thirteenth to Broad, and on the south side of Spring Garden from Thirteenth to Broad. Reserved to

the Committee on Law. The ordinance repealed at the last meeting, authorizing the purchase of ground adjoining the County Prison, for the purpose of extending the building, was taken up. The bill appropriates \$12,500.

Messre, Tan Cleve and Barlow declared that the price demanded was exorbitant.

Mr. Freeman said it might be conceded that the price was too great, but at the same time the public necessities were very great. The prison must be extended, and it can only be done by purchasing ground adjoining.

Col. Page inquired what was done with the Debtors' Apartment. Mr. Shallcross said that the Debtors' Apart-

ment would not be large enough. Mr. Bumm said he was informed by the In-

spectors that the proposed addition would not be large enough for the accommodations at the prison Mr. Freeman said that the city was obliged to



SALE OF A GOVERNMENT HOSPITAL.-The old McClellan Hospital, located at Nectown, has just been sold at auction. The building was erected at the commencement of the Bebeltion, almost exclusively of wood, and was one of the largest and best regulate 1 hospitals in the country. At different times during the war about forty thousand sick and wounded soldiers were there accommodated. The wings attached to a central building were sold separately at prices ranging from two hundred and fifty to four hundred dollars each. The entire proceeds of the sale amounted to about seven thousand dollars, a small sum compared with the original cost.

DEATH OF AN OLD OFFENDER .- Edmund Pendleton, allas Long, alias Dutcay, died in prison a few days since, where he was serving out a term of imprisonment for burglary. At out a term of imprisonment for burglary. At the time of his decease he was about twenty-four years of age. Pendleton has been engaged in the ving operations since his boyhood. His first offense was committed when he was about thirteen years of age, having broken info a bouse and robbed it. He was soon after caught and placed in the House of Refuge. He after wards took to pocket picking, and theving gene-rally, and was so well known to the detectives that he seldom escaped. The cause of his death is unknown. is unknown.
