Civil Rights in Maryland.

COMPETENCY OF COLORED WITNESSES.—CONFLICT BETWEEN FEDERAL AND STATE LAWS.—UNITED STATES LAWS PARAMOUNT.—CIVIL RIGHTS BILL SUSTAINED.
