BOARD OF SCHOOL CONTROLLERS. - A stated meeting of the school Controllers was held yesterday afternoon.

A communication was received from the Third Section asking an appropriation of \$500 for repairs to the Mount Vernon School building, Referred. From the Sixth Section, asking that \$30,000 of the loan be set apart for the building of a school-house at Crown and Race streets, Reterred to Councals.

From the Twenty-seventh Section, asking that \$20,000 of the million loan be set apart for the erection of a school-house on a lot on Ludlow

street, below Thirty-sixth. Referred. The Committee on Accounts reported their approval of bills to the amount of \$10,815'43, which were ordered to be paid. The Committee on Property reported that an additional appropriation of \$2000 will be re-quired for rent and additional buildings and repairs.

repairs. Referred to Councils. Mr. Haines offered a resolution closing the office of the Board for three weeks, so as to allow the clerks and messengers an opportunity to recreate.

Mr. Given thought the Controllers should constder whether it is not requisite to have the office open every day in summer. Mr. Shippen said that great inconvenience

might arise from the closing of the office for several weeks, and he understood that an arrangement had been made by which the office

would be kept open every day. Mr. Haines-Not if the resolution passes. I suppose the resolution of the Board will supersede action in any other quarter. The resolu-

sede action in any other quarter. The resolu-tion was then adopted. Mr. Freeborn offered a resolution of inquiry, as to whether the pupils of the Lincoln Boys' Grammer School had not been allowed a vaca-tion of several weeks while the Principal was preparing boys for the High School examina-

Mr. Levick opposed the resolution. He thought it a matter which belonged to the Sectional Board alone.

Mr. Freeborn was of the opinion that the subject was worthy of consideration. He had heard that in some of the sections school children were allowed to run the street while the Principals were preparing boys for the High School examination. The resolution was adopted.

Smith, teacher of Physical Geography and Constitu-tion of the United States, in place of Miss Mary E. Durnett, resigned. Adjourned.




