CORONER'S INQUEST ON THE MAN SHOT AT THE FIREMEN'S RIOT ON THE MAN SHOT Taylor held an inquest yesterday on the body of Henry Walters, who was shot on Sunday morn-ing, at Moyamensing avenue and Greenwich street, during a firemen's riot. The following testimony was eluciust.

testimony was elicited:-David Jenkins sworn-I live No. 116 Reed street; I am a contributing member of the Shiffer Hose Company; was at the fire on Sunday morning; I was in Bouvier's bar-room about 3 o'clock in the morning; heard the fuss outside: I ran out and I met a man coming from the western side of the street with a pistol in his hand; my friend jerked me in the bar-room and the doors were closed about five minutes after Walkers was shot; doo'l becaution Walters was shot; don't know the man who shot him; I only heard about five shots.

To a Ju or-The man I saw with a pistol was not equipped. James Ellenger sworn - I reside No.

130 Tasker street; I am a member of the Shiffler Hose Company: was at the fire on Sunday morning; know Walters; know one of the prisoners called "Shep:" I saw Walters shot; after the fire was over there was an alarm of another fire; the companies took up hose; the Hibernia's steamer was on the street and the Weccacoe's carriage was alongside of it; a crowd gathered around the carriage, and there was a cry of "Shoot in the bar-room." some one there each "Shoot in the bar-room;" some one then sang out "Let's go for them;" the crowd then came out from the bar-room; a fight was created, and they beat Mr. H. Teal on the head with revolvers; at this time Walters and myself were stand-ing on the pavement; didn't know many of the men in the car-room; they were not equipped; some one said there's one of them on the pave-ment, give it to him; at that moment the man with the duster (James Edmonson) came up to the curb-stone and shot at Walters; immediately after a second shot was fired, and Walters fell on his knees; I don't know whether the loads from the pistol fired by Edmonson shot Walters or not; there were no other shots fired at the time, but immediately afterwards perhaps twenty or thirty reports; the man who fired at

Walters had no equipments on. To a Juror-I am sure Edmonson is the man I don't know him to speak to him, but I have seen him at every fire lately; he is the driver of the Weccacoe steamer.

To Prisoner—I don't remember how you were dressed, except that you were not equipped. Samuel Mclivkin sworn—I was with Walters when he was shot; I don't know who shot him; I caught him in my arms when he fell; he could not speak; Walters was not equipped; had not any pistol that I saw; from twenty to thirty shots were fired after I picked Walters up; a large crowd was in the street when the pistol was fired; did not see a man advance from the

crowd and fire. Policeman Sherr sworn-I was at the fire on Sunday morning; when I first saw it, I ran to the house of the Shiffler Hose Company, and tried to get the carriage out, but the members would not let me; they said that I might take one or two sections of hose. When the fight began in the bar, I went in, and saw one man beating another over the head with a pistol; the crowd got out on the foot-way and there was a number of pistol shots; the hose carriage began to move up the avenue, and I ran out and grabbed one man; he cried out, "You are not going to let me be taken, are you?" three or four shots were then fired at me, and the man got off; none of the men were equipped. David R. Paul, of the Weecacoe Engine Com-

pany, F. J. Cooper, driver of the Hibernia steamer, and Thomas W. Rider, all testified to seeing Edmonson at the carriage while the firing was going on. Dr. Shapleign testified to having made a post

mortem examination, and to the discovery that the ball, a very small one, had passed through the left lung and the aorta, producing deata

from hemorrhage. The jury rendered a verdict that Henry Wal-ters came to his death from a pistol-shot wound, inflicted by James Edmonson, on the morning of September 16, 1866.

The accused was committed for trial.

The prisoner made a statement to the Coroner's jury, in which he said that he always carried the navy revolver, when he was on the steamer, to protect himself and it. He denied

THE BOAT BURNERS .- A further hearing was had yesterday afternoon in the case of Gilbert Adams, charged with conspiring to burn the steamer Meteor, with intent to defraud certain insurance companies. At a previous hearing, Captain Denny, who was in command of the vessel, testified that his brother had been employed to set her on fire by certain of the owners, and yesterday the brother testified as tollows:-

Samuel Dennyl sworn-I reside at' Penns prove; I was employed on the steamship Meteor was on board on the 15th of November, 1865; had a conversation with French previously; he told me everything was ready and to "let the boat go the first opportunity:" the conversation took place on the boat; I was a deck hand on the boat; the steamship came to at Weidner's wharf, at Chester, and about 64 o'clock, all hands being ashore except the steward and one of the deck hands, the boat was set on fire; I did it with a lamp; some rubbish in the forward part of the steamship was fired; the boat was burned to the water's edge; I never received any compensation for it; was to be largely rewarded; that came through my brother to me,

from the owners. Cross-examined-My brother mentioned it to me six weeks before the boat was destroyed; I at first refused; said I would not have anything

to do with it. The testimony here closed, and Mr. Cassidy for the defense called the attention of the Alderman to the fact that the witness had confessed to the commission of a crime, and said he would leave it to him to take such action in reference to it as he saw proper. Mr. Cuyler for the prosecution said he would

take care that the witness was forthcoming to testify at the proper time. Adams was held in \$5000 bail to answer.




