REPUBLICAN MEETING AT NATIONAL HALL—Special of Hon. A. K. McClure.—A Republican meeting was held last evening at National Hall, Market street, under the auspices of the Union League, Henry C. Carey, L.L. D., presided. Mr. Carey, on taking the chair, made a few remarks, after which he introduced the Hon. A. K. McClure, who addressed the meeting upon the political issues of the day. He said he had never been Alderman of his native yillage, and he hoped that he never would be President of the United States. The issues of the present time involved matters of more moment than at any other period in the history of the country, and he entered upon this campaign with great fear and trembling; for he saw that the President would use all the means of the Government to debauch the people. He had travelled the State from end to end, but he had not found a man who had any respect for his character that accepted the bribes offered by the President, but hurled them back with scorn and loathing.

He thought Mr. Clymer would receive as many Democratic votes as had been given at previous elections, but General Geary would receive 25,000 more votes than was ever cast in this State. He was satisfied that Pennsylvania would east a larger vote than ever before. (Applause.) He would also pledge the citizens of Philadelphia that not a single man would be returned to Congress west of the Alleghenies that was not loyal and in favor of the past action of Congress. The issues of this contest rise far Congress. The issues of this contest rise far above Heister Clymer or General Geary, because the Democrats would sacrifice Mr. Clymer to secure the election of one disloyal member of Congress. He then reterred to the condition of the Southern States, and said, that if rebellion worked no forieiture of rights, as proclaimed by the President, the Senators and Representatives elected previous to the war should be the proper Representatives of those States. But while the President says that they are not out of the Union, he directs the course to pursue for the purpose of getting into the Union.

He contended that the Southern States reconstructed under the policy of Andrew Johnson could change their organic law, and undo all that they have done. South Carolina, under the direction of the President, passed laws which again enslave the treedmen of that State, but a week ago laws were passed in that State placing the freedmen upon an equality with the whites; but this has not been done because the people of that State have any more love or humanity for the freedmen, but because they find, since the election in Maine, that the people of the North are not willing to surrender up all their rights. It is not the policy of the Re-publican party to postpone the reconstruction of the Southern States, but to hasten that event as soon as it can be done, so that all the people of the republic snall enjoy equal rights and privileges. It we had faithful men in power, the Southern States would have been in the national fold to-night. We now intend to ac-complish the desired end by teaching the South

teach them on the second Tuesday in October. The speaker said he had no fears for this Gov ernment when the Rebellion was at its height, when the South tried to blot out the Republic by the power of the sword, for then we knew what they were about: but when the men who come fresh from the field of slaughter, with no profession of loyalty, attempt to control the affairs of the nation, it was time for the people to arouse to a full sense of their duty to their country. The speaker then referred to the Convention held in this city in August last, and gave a short sketch of the doings of some of the delegates to it during the Rebellion, and contended that they were not the men to conult on the question of reconstruction.

There was a slowness to secure opportunities for doing good, particularly in helping weak churches and in the erection of new edifices. Wood, Rev. A. J. Hay, Rev. W. E. Watkinson, Brother B. F. Hancock, and others. There was little business transacted in the evening of general interest. Several resolutions elative exclusively to the churches were passed, nd the greater portion of the time was occuled with religious exercises,

Witness went on to say that he was employed as a laborer for a time, and at last was made a foreman in the retort-house; was promoted in 1854; was at Point Breeze Gas Works; Mr. John Murphy was in charge of these works; Mr. Roberts became foreman in 1862; he was foreman when I was discharged; Mr. Roberts discharged me on account of politics; my duty as foreman was to look after the men and report to Mr. Roberts; the men, so far as I knew, were PROCEEDINGS OF SELECT COUNCIL'S GAS to Mr. Roberts; the men, so far as I knew, were equally divided as to politics; I am a Democrat; my discharge was the first made at the works on account of politics; a couple of weeks after, all the Democrats were discharged; I know some

Witness described the duties of a "stoker," also of a "helper;" know Charles Macready; he was foreman of the night gang when I was there; he was discharged and reappointed; his dutie at the works are not such that he could not be spared for a short time if it were necessary witness said that it is important to have experienced men in the retort-house, both as regards the quantity and quality of the gas and the duration of the retorts; if the fire be too strong the retorts will be soon burnt out. Macready was in the practice of absenting himself from the works when his duty required him to be there; when he was discharged, Mr. Wilson, a Republican, was appointed in his place; the gang discharged with Mr. Macready were of mixed politics; a majority of them were Republicans; the men manifested opposition to Mr. Stewart, and interfered with the drafts he made

In answer to a question by Mr. Barlow, wit-ness said he did not see the men do it, but it was impossible for any one else to do it.

In answer to Mr. Page, he said that a retort will last for seven months if there be proper management; if there be not, it may burn out in four months; the introduction of politics he thought injurious to the works; Mr. Stewart, when Chief Engineer, did not discharge men on

account of politics,

ANOTHER TRAGEDY .- About 7 o'clock last evening, a German named Jacob Meirs, aged about fifty years, was snot in the left breast and mortally wounded by one John Keyser, at their residence, in the rear of No. 1220 Palethorp street, above Girard, avenue The facts in reference to the shooting are as follows:

—Both men live in the same house; the former occupies the third floor, and the latter has pos session of the lower stories. Mr. Meirs is an industrious man of temperate habits, and much respected by his neighbors. Keyser is addicted to drinking, and yesterday afternoon about 5 o'clock he returned home somewhat under the influence of liquor. He exhibited to his wife a pistol, which he stated had been given to him by an individual on the whart. Mrs. Keyser inquired of him if the weapon was loaded, to which he replied in the negative. Shortly before the unfortunate occurrence took place, Keyser laid the pistol on a table and proceeded up stairs to Mr. Meirs' apartment, and paid him his month's rent. Mr. Meirs returned to Keyser ten cents to purchase a drink with, whereupon tol. Keyser proceeded down to inspect the pis-tol. Keyser proceeded down followed by Mr. Meirs, who, on reaching the first floor, was handed the weapon, which he look floor, was handed the weapon, which he looked at and then replaced on the table. Keyser again lifted the weapon, and closely examined it, at the same time turning it over and over in his hands He then raised the pistol, pointed it at Mr. Meirs, and pulled the trigger, the ball from the weapon taking effect in his left breast, producing a severe and, it is feared, a fatal wound. The report of the weapon attracted the attention of Officer Dunlap, who at once repaired to the dwelling, and arrested Keyser. On his way to he Station House he did not deny shooting Mr Meirs, and at once produced the pistol, which he had on his person. The accused was locked up in the Seventeenth Ward Station House, to await the result of the injuries inflicted. Doctors Bethel and Orr were called in, and attended the injuries of the wounded man. He was suffering with great pain during the entire evening, and at a late hour last night he was not expected to live until morning. Mr. Meirs stated that he did not believe Keyser intended to shoot him, as the most friendly feeling had always existed between them. He was of the opinion that Keyser was not aware that the weapon was

FURTHER HEARING OF ONE OF THE PRESron Hill Burglars .- At the Central Station yesterday, Michael McGee, commonly known as Tully McGee, had a hearing on the charge of burglary. He is alleged to have been of the party who broke into the store of Mr. Preston L. Hill, near the Blue Bell tavern, on the night

of the 10th of August.

Mr. Hill testified to the breaking into the store, and to the fact that he discharged a gun loaded with shot at the depredators, and to wounding of one of them. Only one of the party was arrested at the time, named Campbell. He was convicted, and was sentenced to five

years' imprisonment. McGinley, keeper of a tavern Twenty-third and Naudain streets, testified that on the evening preceding the robbery McGee was at his house, in company with Campbell, and drank at the bar with him. He could not say whether they left together or not. Defendant was arrested at a house in Pine street, near Twenty-sixth, by one of the officers of the Fifth District, who, upon examining the back of the prisoner, discovered that it was covered with shot wounds. The coat he had on was also full shot holes. The reason given for McGee not being arrested before was that he could not be found. He was committed for trial.
