A report from the Cholera Committee indi-cated that it had held itself ready for prompt action during the summer and fall, should exigencies, in the outbreak of a violent epi-demic of cholera, have demanded it. At present no further action on the part of the committee was needed, no cholera hosp'tals having been established by the city authorities, nor any dis trict cholera physicians having been appointed, Some discussion ensued on the subject of

cholors itself, and the influence that the enting of cysters had produced towards increasing the number of cases of the disease, Dr. W. Williamson then read an able and in-

structive article on the cause, phenomena, and homocorathic treatment of intermittent lever. A debate on this disease was engaged in, and continued until the hour of adjournment. There are between one and two hundred active homoro pathic practitioners in Philadeiphia. The sys-tem has proved itself cminently a success, so much so that it is a matter of surprise among hemocorath sts that the managers of hospitals and other charitable institutions do not set arart special wards, to be under the manage-ment of reliable homeopathic physicians.

INVESTIGATION OF HOUSE ROBBERIES .-There was a very interesting hearing or several There was a very interesting hearing of several persons concerned in recent house robberies at the Central Station yesterday alternoon. Wil-tiam Donnelly alias Dunn, Charles Lechler, and George Ellison were charged with being implicated in them. Frank McCarten testided to the robbory of Mr. Clyde's residence, No. 1710 Arch street, on the 13th of September, from which a considerable quantity of wearing ap-part was stolen. He did not, however, identify any of the defendants. any of the defendants.

Thomas J. Willits testified that he was working at the Church of the Covenant, Filbert street, above Seventeenth, when the robbery at Mr. Clyde's house was committed. Several men came and stood about the church for some time. He recognized Leonard Duford, otherwise Shoey M dier (1 ow under commitment for the robbery) Lechler, and Donnelly as the men he saw. Miller asked Donnelly when he expected h s pa to come nome, and the reply was that he ex-pected him home in a couple of weeks. This was intended to induce the behef among the work on that they helpered to the behef worknen that they belonged to the premises of Mr. Clyde and had a right to enter. After re-maning at the church for some time, two of the men disappeared—Miller and Donnelly—Lech-ler remaining. Fivally, he too left, and the set have mendicated a barticipation of the set of rothery was discovered a short time after, when Miller hal been arrested. The witness did not recognise Ellison as one of the party.

James T. Rutter, sexion of the Church of the Covenant, saw the men about the church, and thought he recognized Lechler and Ellison, but would not swear positively to it.

Mis. Margaret Vaux testified that her residence, No. 1148 Arch street, was broken open on the 24th of August, and robbed of a variety of silk dresses, made and unmade, silver ware, and other articles, altogether of considerable value. The thieves first pried open a rear window, then broke a panel out of a door. A chamber door was forced open, but the bureau drawers were unlocked at the time.

Mrs. Elizabeth J. Sharpless testified that her dwelling, No. 1315 Filbert street, was broken

dwelling. No. 1315 Filbert street, was broken into towards the end of September. A kitchen window was forced open to admit an entrance. Seven dresses were taken, besides a number of silver spoons, butter knile, etc. Albert Miller testified that Mrs. Gough's house, at Sumner and Seventeenth streets, was broken into some time ago and ransacked from top to bottom. A quantity of wearing apparel was carried off, but he could not give an idea of the value of the property stolen. The thieves entered by prying opon a side door with a jimmy. jimmy.

John Ward testified that the residence of Mr. Edmund Smith, No. 1504 Arch street, was robbed on the 9th of September of goods to the value of about \$800. A jummy had been used on the window shutter.

Leonard Duford, otherwise Miller, implicated in several of the robberies, was now called to the stand, and testified that he and Lechler and Donnelly robbed the house of Mr. Clyde, but he said he did not know anything about the rob-beries at the residences of Mrs. Vaux and Mrs. Sharpless; all he knew about was the robberies at Mr. Clyde's and Mr. Frishmuth's. In de-scribing the robberies, he said that he climbed over the fence, jimmled the window open, and after they had got what they wanted, climbed Leonard Duford, otherwise Miller, implicated


