An examination of the matter had railed to satisfy the Com-mittee that the claim is well founded, and they asked to be discharged from the further con-eideration of the subject. Agreed to. Rev. Dr. Schetky moved that it be the duty of each clergyman, on Advent Sunday or some of the Ember Days, to preach a sermon calling the attention of the people of his parish to the need of the Church for young men for the minis-try, which was carried. Rev. Dr. Spear officed a resolution to the effect that the Board of Diocesan Missions be nuthorized to issue a periodical containing state-ments in regard to the work. Adopted.

Mr. Williamson, of Wilkesbarre, were placed upon the Committee on the Division of the Division of the Diocese. The Committee were instructed to confer with

the Bishop and report thereon. This motion clicited considerable discussion, in which Rev. Mr. Cummings, Dr. Hare, Mr. G. M. Wharton, and others participated. It was moved to lay the motion on the table,

and upon it the yeas and mays were called. The motion to lay on the table was lost. Of the clergy 36 voted for and 50 voted against; of the laity 14 voted for and 17 voted against.

Mr. Welsh moved to amend by the insertion of the word "recommended," instead of "in-structed," which was carried. The original resolution was then carried.

After the usual religions services the Conven-tion, at 8 o'clock last evening, adjourned sine die.

SLIGHT FIRES .- A slight fire occurred at No. 1315 Alder street, in the Twentleth Ward, yesterday afternoon about four o'clock, caused by a

child playing with matches. The roof of a lager beer saloon, on Second street, above Dauphin, in the Ninteenth Ward, was damaged by fire yesterday afternoon. It originated from sparks from an adjacent

foundry. About nine o'clock yesterday morning, the house No. 1713 Carlton street, in the Fifteenth

Ward, was slightly damaged by fire. The alarm of fire about eleven o'clock last night was caused by the partial burning of the office at Wood's woollen mill, at Twenty-fourth and Hamilton streets. The fire originated among some yarn, and the damage done was triffing.

There were some eighteen hundred people in the house, the entire lower portion and the balcony being filled. The last act of *Elizabeth* had begun, at a few minutes before 11 o'clock, when some one in the upper tiers cried out "fire," and instantly the audience were on their feet, some of them starting for the door. The actors had the good sense to immediately resume the play, and the panic to immediately resume the play, and the panic was over happily without any one being hurt. It is well to state that the alarm of fire came from the street.

MEETING OF THE SOUTH STREET BRIDGE COMn.-The Commission appointed by the Legislature to superintend the building of a bridge over the Schuylkill at South street, held an adjourned meeting yesterday, John Welsh, Esq., President. Mr. Spering, President of Select Council, stated that in consequence of the action of Councils referring the subject of the constitutionality of the act under which the Commis-sion acted to the City Solicitor, he thought it advisable to withdraw from the Commission Mr. Kneass, the Chief Engineer, who was friesd by inclution, presented several plans of a bridge, and one showing the arrangement of streets on the west side of the river; also such details as would enable any one to put in pro-posals for the construction of the bridge. Mr. Dropsie submitted the following:-Re-solved, that the centre line of the bridge shall be located as follows:-From a point in the south line of South street, 350 feet from the westerly side of Sutherland avenue, to the inwesterly side of Suthernand avenue, to the in-tersection of scuth side of Locust street with the southerly side of Darby avenue, in accord-ance with plans submitted by Chief Engineer. Which was adopted. Mr. Wetherill offered a resolution, that the Committee on Plans submit the width of draw of proposed bridge to the Board of Surveyors for approval. Agreed to. Adjourned. THE KELLEY HOMICIDE IN CAMDEN-CONVIC-THE KELLEY HOMICIDE IN CAMPEN-CONVIC-TION OF THE PRISONER.—The jury in the case of Davis Kelso, who was charged with killing William Kelley on the 5th of February last, and whose trial has occupied since last Tues-day, after remaining out about half an hour last evening, rendered a verdict of guilty of murder in the first degree. This is the first verdict of the kind that has been rendered in Camden county, and for once, if the prisoner is not pardoned, Sheriff Sharp will have a dis-agreeable duty to perform. agreeable duty to perform. Allen C. Scovel, Esq., conducted the case on behalf of the prisoner, and addressed the jury for three hours and a halt; but the case was so strong against Kelso that, not withstanding the carnest appeal in the prisoner's behall, the jury felt justified in rendering the verdict they did. Bichard S. Jenkins summed up the case on the part of the State, completely overturning the theories advanced by the counsel for the detense.

More ROESERIES.—An iron safe in the base-ment of the Friends' Meeting House, at Fif-teenth and Race streets, was optned by some unknown person, on Wednesday night, and a box containing Government bonds and city toans to the amount of \$2100 carried off. 
