THE NICHOLSON PAVEMENT .- Notwithstanding the rain, the Nicholson pavement on North Broad street makes fair progress. It is now finished and ready for use as far south as Jeffer-son street. In all the pouring rain yesterday afternoon the men engaged upon the pavement were at work, and the movable fornaces employed in heating the gravel and melting the pitch were sending up their clouds of smoke in the face of the descending torrents. Drenched to the skin, the men yet worked on right cheerily. The street is unpaved and pre-pared for the flooring as far as Master street. while the timbers and blocks are lying along the sidewalks south of Thompson street. The water runs from the finished portion of the pavement as from the surface of a polished table; no mudholes or gullies can be found. The street affords as clean and clear a surface for travel as it did in the most dry and favorable weather. As a highway for vehicles it cannot be surpassed. What will be its condition when the frosts of winter enter the gro und and beein their upheaving process in the spring, remains yet to be seen.

A CAMP MEETING ROBBERY .- Rev. A. Manship, Pastor of Calvary Methodist Episcopal Church of this city, has returned home from the Concord Camp Meeting, held in Caroline county, Maryland, minus his watch, a quantity of cloth-ing, and some fifty dollars in cash, stolen from his tent by some advoit thief. He was engaged last Sunday the entire day and evening, and retired with another minister shortly b eleven o'clock. The watch was a present to Mr. Manship, from a congregation of which he was pastor nineteen years ago, and the guard was very highly valued as a memento of the deceased wife of Mr. Manship. A Woman One Hundred and Seven Years Old.

Prussian Losses in the War.

The Journal of the Royal Statistical Office at Berlin gives the first official report that has been published of the losses of the Prussian army in the last war. According to this report the effective strength of the army brought into the field by Prussia and her allies was 437,262 men (including 129 generals and 8964 officers) and 110,192 horses. The total number of the wounded was 669 officers and 15,508 men; of those who remained on the field, 178 officers and 2753 men; of those who died of their wounds, 64 officers and 1435 men; and of those who died of illnesses contracted during the campaign, 53 officers and 6734 men. The total loss amounts to 315 officers, 10,562 men, and 6490 horses. The number of officers wounded was relatively twice as great as that of the private soluters.

SUSPECTED THEFT .- Last evening a crowd was collected at Sixth and Pine streets, owing to the arrest of a colored man who attempted to dispose of a valuable gold watch and chain to a jeweller, whose place of business is on Sixth street, above Pine. The chain had been ap-pended to the watch by means of a ring, which was bent in a manner indicating that force had been used in taking it from the watch. The storekeeper suspecting that the watch and chain had been stolen, called in a policeman who was passing, who took the alleged thief to the Fifth Ward Station, where he gave the name of John H. Kelly. He was locked up for a hearing.

THE FRAUDULENT BOND TROUBLE IN THE THIRD DISTRICT .- Arrests continue to be made of persons alleged to have been concerned execution of fraudulent bonds in the Third Collection District of Pennsylvania. Two of the parties to one of the bonds were arrested in New York on Wednesday, and one of them was brought to this city by Revenue Inspector Wood, The other will be brought on to-day. An arrest was made in this city yesterday of a resident, and a reported man of means, on the charge of having aided and abetted in the execution of the bonds. The accused will have a hearing in a few days. The United States District Attorney has been working energetically for some months to get at the parties concerned in these frauds.

The Jewelry Manufacture in France.

A Parisietter to a London paper says :- "The jewellers and goldsmiths of France are a most important body, and are continually increasing important body, and are continuity inclusing in numbers, as a stroll among the jewellers and trinket-makers will soon prove to the visitor who remembers the French jewelry and gold-smith's work of 1855. Paris is the centre of the trade; but there are great branches of it at Lyons, and Marseilles, and Besucon. A great inpidary trade has arisen, moreover, in the Jura. The quantity of gold annually used by French jewellers and goldsmiths is estimated at seventeen tons, while the manufactured silver amounts to eighty-nine tons. The total annual value of the gold and silver work of France is set down , at £3,825,600, exclusive of precious stones. There are 20,500 persons in the trade, of whom 12,500 are strictly workmen. The number of manufacturers is 1250.

"This great trade is carried on, as a rule, in small workshops, and it offers to the inquirer exceedingly favorable views of the French small workshop system. There are not many masters who employ more than eight or ten workmen. A great many of the skilled men work apart, and employ one journeyman and apprentices. The female labor used in this trade is confined to the polishing process. Since the exhibition of 1655 machinery has been largely introduced into the trade without, the Committee of Sclec-tion maintain, harming the character or finish of the work. The French Committee asser that 'plated gold jewelry is without a rival abroad, and enables French commerce to com-pete with the low standard gold work of England and Germany.' The social conditions under which this trade is now carried on appear to be extremely happy, and favorable to its prosperous development. Since 1855 the masters and workmen have formed themselves into a common association for the amicable adjustment of their respective interests"




