REPUBLICAN MASS MEETING IN THE PIFTEENTH WARD. A large and enthusiastic meeting of the Republicans of the Fifteenth Ward was held last evening at Twentieth and Coates streets. A stand for the speakers had been erected on an open lot fronting on Coates street, and all the space in front of it was densely packed by the hearers. The place was so selected and the surrounding buildings so situated that the speakers could be heard to a great distance. The meeting was organized about 8 o'clock by the election of Henry Davis as Chairman.

The resolutions were read by Mr. H. W. Gray, and received with great applause. They were drawn up by the same gentleman, and are as follows: last evening at Twentieth and Coates streets.

The Union Republican citizens of the Eleventh Ward, in mass meeting assembled, declare:

First. That the present atarming condition of our national affairs admonishes every patriot to increased vigilance and activity in the approach. ing general election. Every vote polled for the so-called Democratic ticket will be regarded as a vote approving and sustaining the treachery and periody of that bad man whom we unfortunately alexand Vive Democratic votes. nately elected Vice-President of the United States. Should the great State of Pennsylvania now fall into the hands of the man who de-clared the war a fallere, and who could at the Presidental election next year surround our voting places with traitor sheriff's deputies and constables, the whole nation would feel the terrible effects of our folly and shortsighted-

Second. That the course of the accidental President, Andrew Johnson, in removing the mithful Secretary of War, Elwin M. Stanton, and those war-tried soldiers, Sheridan and Sickles, is the first step on the part of the fatthless Executive to place the power of the Gov-ernment in the hands of Rebels and their allies, and meets with the earnest remonstrance of General Grant and every other true soldier and

Third. That now and here we renew our pledges to preserve the integrity of the Union, and secure the just fruits of our victories.

Fourth, That the candidates presented by the

Union Republican party for our State, City, County, and Ward officers, are well known as devoted Union men; and as none of them have ever been known to shoot one way and vote another, are all justly entitled to our undivided support; we therefore earnestly invite the active co-operation of all men who love their country, in the election of our whole ticket; and, laying aside all minor differences, to again defeat by their ballots the men they have once detested by their bayonets.

He spoke of the end of the political strife that

now agitates the country, and against the principles of Judge Sharswood, which, he said, were against those our soldiers tought for.

The Hon. Morton McMichael was then intro-

duced. He assured his bearers that the coming election was sure. Some few months since he had misgivings, but had none at the present time. He stated that at one time he feared that because the Republicans had gained so many victories they would rest supinety, and in consequence be defeated at the ensuing elections. He said that the speeches of Andrew Johnson made many votes for the Republican ticket, and had no other effect.

Colonel William B. Mann, Captain Curry, of Fort Delaware, and Colonel Frishmuth after-wards addressed the meeting, after which it adjourned.

ADJUSTING THE TAX RATE FOR 1868 .- Last evening the Finance Committee met and con-sidered the question of a tax rate. There was a full meeting of the committee, and the subject was introduced by a motion of Mr. Stokley to fix the rate at \$1.40.

Mr. Harper suggested that this would be use-less, and the rate would not produce the amount actually required, according to the Controller's statement. If \$1.40 is decided upon there will be nearly \$300,000 short of the amount needed to pay the appropriations. In addition to this, there would be no margin for contingent expenses.

Some discussion followed in regard to the reliability of the estimates, and Mr. Hancock was appealed to with reference to the several was appealed to with reference to the several Departments and the probability that the amounts specified would be all that would be demanded. In answer, Mr. Hancock said that when first applied to, the Gas Trustees had reported that the amount for lighting the city in 1868 would be the same as in 1867, but since the estimates had been put in form they reported that \$150,000 more than the first estimate would be needed. In this extra amount \$65 per lamp was proposed to be charged for each lamp, in-stead of \$48, as last year. As an offset to this, the members of the Board of Revision had stated during the day that the estimated value of real estate as printed was below the actual figures, as there would be added to that sum from \$15,000,000 to \$20,000,000 for improvements now in progress and to be finished before November. In November there will be another assessment, and it \$15,000,000 be added to the value of real estate, this, at \$1.40, will yield \$210,000 more in

taxes than is estimated now. Several members suggested that the estimated appropriations to the department could be cut down, while Mr. Potter said he believed the city could anticipate \$50,000 more income from the Water Department than is estimated in the Con-troller's Department. After this discussion, Mr. Spering moved to make the rate \$1.45; Mr. King moved to make it \$1.35.

Mr. Spering urged that if \$1:40 was the rate there would be a deficiency of at least \$200,000, and \$1:35 would still further increase the defi-Mr. King said that be proposed to cut down

the appropriations, in order to make the rate cover the expenses of 1868. Mr. Spering said he did not believe the appropriations would be cut down to any very great extent, unless it was proposed to have extra ap-

propriations before the close of the year.

Mr. Potter said he believed that \$1'40 would be sufficient, because we might expect an increase on the valuation of the property, while there would be an increase of the income. But he could not seen how \$1'35 would be enough.

The motion to make the rate \$1.35 was lost—yeas, 3; nays, 9. The motion to fix the rate at \$1.45 was lost—yeas, 2; nays, 10.

Lr. Swann, arose and said that when men like him went into politics the people must begin to think there was a great crists in the country. He had been ridiculed in the papers as a medi-cine man and a humbug. He reviewed the efforts of the conservative party and advocated supporting Democracy.
