MORE FRAUDS .- Chief Lamon, of the Detective police force, in the early part of the week received word that a council of Rebels and so-called Democrats had been convened in Baltimore, where plans were matured for the purpose of sending Maryland secessionists to this city to and the Democracy in carrying the election. A number of leading Democrats of this city were present at that meeting, and assured their Baltimore friends that they would aid them in carry-ing out their devilish designs.

Mr. Lamon's information proved correct, for the trains from the Monumental City on Wed-nesday night were thronged with the roughs sent to this city to vote the Democratic ticket. The Chief was at the depot with a po se of men, and when the Plug-Ughes alignted from the cars a raid was made upon them, and ten of them were captured and locked up. Yesterday afternoon they were taken before Alderman Beitler, at the Central Sintion, where they gave the following names, residences, and occupations:-

etreet. George Kenney, seaman, No. 22 Thames street. The prisoners were decoded by I. Newton Brown, assisted by two or three lesser lights of the Rebel Democracy. Mr. Brown took a most acuve interest in behalf or his friends, the like of whom the leaders of his party delight to benor. honor.

The evidence which we print shows that the same prisoners, while on the train, beat Union soldiers, sang the Rebel air of "Bonnie Blac Flag," and cheered for their favorites, Seymour and Blair. The first witness examined was Jacob H. Rich-

ardson, of No. 325 I street, Washington, clerk Supreme Court of the United States, who deposed that he came here on Wednesday evening; that was badly injured while on the train; recognized Hutchins as among the number who sang the Rebel song of the "Bonnie Blue Flag;" after this they gave cheers for Seymour and Blair; several of the Boys in Blue cheered for Grant and Colfax; Hutchins knocked witness senseless with a club; the assault occurred just outside of Baltimore

George D. Johnson, residing in Washington, L. C., saw the crowd come in and cheer for Sey-mour and Blair; then they sang the "Bonnie Blue Flag;" he recognized Hutchins, Rooney,

and Feters as being in the party. James T. Wormley, of Washington, testified that he was on the train coming from Baltimore, and saw Hutchins, Rooney, and Selvage in the cars cheering and singing.

William G. Craw/ord, residing in Washington, deposed that he recognized Peters and Selvage as being with the party who made the attack. Policeman Kenny, First district, arrested Stanton; found a loaded revolver on his person;

also arrested Morris and Rooney. Chief Lamon testified that he ordered the arrest of defendants; that on Tuesday he re-ceived information to the effect that parties in Baltimore were arranging to send men here for the purpose of voting at the coming election that two hundred were coming on Wednesday; and that he arrested the defendants as the per sons who were mentioned in the description he

had received. Mr. Brown requested Mr. Lamon to make public the information. Mr. Goforth, for the Commonwealth, said that

it would be improper for the Chief to state who his informants were, as their lives would be in danger in case he should do so.


