The petition of the citizens contesting the election of Furman Sheppard to the office of District Attorney is nearly similar to that in the case of the Prothonotary of the Court of Common Pleas. The general return of votes sets forth 61.165 for Mr. Sheppard, and 59,890 for Mr. Gibbons, giving the former a majority of 1275 votes; which they allege to be a false and fraudulent return, declaring that in truth Mr. Sheppard did not receive more than 75,000 votes, and Mr. Gibbons did receive at least 57,540, which would give the latter a majority of 2000.

#### FROM SAN FRANCISCO.

The Earthquake - The Walls of the Buildings in the City Damaged-Great Excitement.

San Francisco, Oct. 22 .- The earthquake is still the topic of conversation. A slight tremor or two have been felt to-day. The total of the casualties worth mentioning do not exceed thirty. There were only five persons killed, though in one or two instances persons who were struck by failing bricks and timber may dle of the injuries received.

A committee of the Board of Supervisors. assisted by several architects, to-day held a survey of the City Hall, fire engine houses, and other public buildings. The examination of the City Hall shows that the walls are badly cracked from the ground floor upwards, and the aisles are mostly rained. The Post Office clerks have resumed their duties. The Post Office occupies the lower story of the Custom House building. Had it not been for extra anchors and ties put into the Custom House building after the earthquake of 1865, it is probable that the greater portion of the structure would have fallen to the ground.

The old Merchants' Exchange, on Battery street, opposite the Custom House, and which for some years past has been occupied by the United States Courts, was considerably injured. There is a large fissure in the north wall of the building.

The Custom House and old Merchants' Exchange are on made ground, beyond the original water front of the city. Their foundations rest on piles. The old Exchange was severely shattered by the earthquake of 1865. The new Merchants' Exchange, on California street, was slightly lojured. The ornamental work on the building occupied by the Bank of California was thrown down. The balustrade and chim-

was thrown down. The balustrade and chimneys are being removed.

Aithough a hundred buildings in the city have been damaged more or less, a thorongo examination proves that those buildings which have been properly constructed will stand much heavier shocks than those of yesterday. The Occidental and Cosmopolitan hotels and the Lick House and the Ross House, the largest buildings in the city, are unipjured, except that in some instances the chimneys were thrown down and the plastering cracked. These buildings are all on solid ground.

The damage west of Montgomery street was very slight, very few buildings occupying solid ground showing any damage whatever To-day's lexamination only confirms yesterday's report, that the greatest wreck of buildings and destruction of property were con-fined to the eastern and southern portions of
