During the fifteen years I have devoted a very considerable partion of my time to the public service in educational matters, at the sacrifice private business and duties, and I now feel it due to myselt that I soull relinquish further participation in public school affairs.

I will ever bear in pleasing and grateful memory the distinguished nonor you have con-ferred upon me in calling me to the Presidency of your Board, the courtesy and kindness which have always marked our official and private relations, and, above all, the earnest zeal, intelilgence, and faithfulness to public juterests which have so signally characterized the term of service of each member of your Board. Believe me that I dissolve our official relations with the greatest relaciance, but not without matured deliberation. Our private relations will remain undisturbed.

Receive singly, geo lemen, the assurance of my sincere wishes for your happiness, and for continued success of the great cause so happily conded to you, and believe me, very respectfully, your obedient servant, EDWARD SHIPPEN.

## FROM WASHINGTON.

#### General Grant and the Washington Politicians

WASHINGTON, Nov. 10 .- This afternoon a com n littee, consisting of delegates from the Soldiers and Sallors' Republican Committee, officers of the Boys in Elue, the President of the Central Grant Club, the Mayor of Washington, and aldermen and citizens, called upon General Grant by appointment. The object of the visit stated in the following address of the Mayor:-

General Grant-In behalf of the citizens and the Republican organizations of this city, we have called to tender our hearty congratu ations on the result of the recent election, and to make known to you their withes that they be permitted to attest their feelings of happiness and joy by a proper public demonstration, we coming you as the President elect to the capital of the nation. As they were deprived of that pleasure on your arrival here by a sort of fank movemen, by which you stole a march on our people, all indulge in the hope that you will now accede to their request, and name a time and place that will be most agreeable to you for such a demonstration."

General Grant responded as follows:-"I am shad to meet you all, and to receive your con-grate ations, but I nope you will spare me any public demonstration. I live in this city, and like to avoid demonstrations here as elsewhere, and with my consent there cannot be any. am always ready to meet such gentlemen may call upon meat my office or house at any unce, without public display or demonstration. This would be much more agreeable to me, and hope it will be agreeable to you."

The Mayor replication "We shall certainly study your pleasure in the matter,"

General Grant said:-"I am not unmindful of the iceling intended to be di-played by a public demenstration. You must take all this for 'granted.'" (Laughter.)

A lew moments were passed in conversation, and the committee withdrew, each member of it inking Grant by the hand.

There is much drappointment at the retusal of General Grant to accept a public demonstration, as the pre-imiuary arrangements had been made for a grand display. General Grant was at his office to day, from 9 A. M. until 3 P. M., for he performance of official duties, though constantly interrupted by visitors.


