## FROM WASHINGTON.

### Return of a Revenue Cutter.

Washington, Nov. 23.-The steam revenue cutter Wayander, Captain J. W. White, has just returned to San Francisco from a similar's cruise to Alaska, besides visiting many points of interest and importance south of the Aleutina Islands, already comparatively well known. The chief object specially in view was successfully accomplished in visiting the important and valuable islands of St. Paul and St. George and the coasts of Bebring's Sca. ## The Romance of Bankruptcy.

ENOCH ARDEN OUTDONE.

Under the above caption the St. Louis Republican tells a rather sensational story, which we condense as follows:-

"Who is it that does not remember the financial crash of 1857 ? Many of our most enterprising merchants had to succumb to the pressure of the times. Among them was a merchant whom we shall call 'Smith.' His real name and some of the circumstances we are about to relate will doubtless be recollected by many in St. Louis, even to-day. He kept an extensive mercantile establishment on \_\_\_\_\_ street, and by his enterprise and promptitude won the confidence of the best houses in the Bast and West.

"He had a young wife and three little children. They lived in a neat little villa in a fashionable portion of the city, and the neighbors said a happier family oid not exist in the State of Missouri.

"The crash came; his debtors were unable to meet his calls, and, as a consequence, he was unable to meet the demands of his creditors His first resolve was to make ever the villa to his wife and family and secure an annuity of \$600 a year for the support of herself and children, and leave the city secretly. So one night he sallied forth, determined to rebuild his fallen fortunes or perish in the attempt. Proclamations and rewards were of no avail, and the universal verdict was-'mysterious disappearance."

"Mrs. Smith mourned her husband as dead for two years, till she wisely concluded it was useless to mourn any more, so she decided to receive the long proffered attentions of William Bradford, an old bachelor, a companion of her late husband.

"But her happiness was not destined to be perpetual, for William Bradford was afflicted with consumption, and died during the last spring, leaving his wife for the second time a widow. To her and his children fell his business, which she converted into cash, realizing a sum that placed herself and her children in easy circumstances.

"During all these years what became of Smith? He made his way to Montana, and worked in the mines, where his intelligence and enterprise soon put him on the roat to wealth. Some years after he went there the small-pox broke out among the minors, and he caught the infection, from which he recovered, but so pitted that his mother would



#### City Affairs.

At the close of the supper, Mr. Colfax was-introduced to the audience and made a short address, in the course of which he sai. that no man occupying a public position felt more keenly the kindness that had been bestowed upon him, and that his heart warmed towards those who (many unknown to him) had aupported and sustained him through the last exciting contest. He concluded by returning thanks for himself and Mrs. Cultar to the audi ence for the cordial reception extended to them -A party of firemen were out on a jolly trobe

last night. They were out to screwade a fellow member, who had just gat married. They carried a banner, inscribed with the words. "Maurmann Hose, No. 1776," and bearing on the reverse something like a phomix, or perhaps a spread-engle, with the motto, "Bird up." The report that an insurrection was organ iz-d in Sierra Puebla by Mendiz and Negrete

proves unfounded. The Mexican journals are discussing the pro-bable policy of the United States Minister, Rosecrans, and indulge in much speculation as to what action Grant, on assuming the Presi office, will take concerning the reladential tions of Mexico and the United States.

The Mexican Secretary of the Trensury has issued a circular, complaining that the officers of many of the Custom Houses disobey the orders of the department at Mexico, and act alogether according to their own will.

#### General Grant's Fortune.

The Washington correcoondent of the St. Louis Democrat says:-"General Grant is r ch already, and by contious investments he is detined to be very rich one day, ranking with the most opulent. He owns thirty-eight acres of hand within the corporate limits of Washing-ton, worth \$2000 an acre. His house here is held at \$60,000. A farm near St. Louis and houses at Galena and in Philadelphia should add \$100,000 to the former items. Three hun-dred thousand dollars will probably be not in excess of the President elect's possessions. Meantime his commercial training and fondness for material speculations, aided to his good luck and caution, are exemptifying themselves in judicious operations in many honorable fields. It is allogether probable that we shall base in Grant a President who, exercising all due liberality and ho-pitality in the Chief Magistracy, will be the first President since Washington to be discreet and practical in the management of his private fortune. H & comparative youth will permit him, should be live to the aver ge are of Presidents, thirty years duration after the expiration of his term of office."


-M. Herve has roused the ire of French eritics by taking for the subject of his opera bouffe, Chilperic, at the Folles-Dramatiques, the life of a Merovingian monarch. "The line must be drawn somewhere." The heroes of ancient history, the goddesses of Pagan mythology, are fair game; but due regard must be had to a French king, however distant the times in which he flourished. In one respect M.
