-A petition to Congress for a change in the naturalization laws, drafted by the Union League of New York, has been sent to Washington. It bears twenty-seven thou-and signatures and is five hundred feet long.

### Foreign Affairs.

LONDON, Feb. 17 .- An address in reply to the Queen's speech was agreed to unanimously in both Houses of Parliament. In the House of Commons, last evening, Disraell expressed sorrow that the ratification of the convention with the United States was not commenced. He hoped, however. for a speedy completion of the treaty. Mr. Gladstone was sure the negotiations would end in the same spirit in which they commenced. The final issue would doubtless be satisfactory to both countries.

PARIS, Feb. 17 .- The report that ex-King Ferdinand of Portugal has consented to be a candidate for the Spanish throne was premature. Though strongly urged, he still refuses to allow his name to be used in connection with sovereignty. A majority of the members of the Constituent Cortes, now in session at Madrid, are opposed to the Duke de Montpensier, and there is little prospect of his ST CCC88.

MADRID, Feb. 17 .-- In addition to the large reinforcements about to sail for Cuba, the government will send out, as soon as the necessary transportation is ready, another expedition, which will number at least 6000 men.

HAVANA, Feb. 17 .- Transports arrived in the harbor to-day with reinforcements of regular troops from Spain. P

The number of arrests for political causes are daily increasing. Several officials have been thrown into prison on suspicion of revolutionary proclivities. Engagements between the troops and the rebels are reported to have taken place near Trinidad, Cienfuegos, and Espirito Santo.

The Diario states that the insurgents near Sagua la Grande are completely surrounded by government troops, and will be compelled to surrender.

NEW YORK, Feb. 17.—A special to the Herald, dated Havana, Feb. 17. says: The second telegraph cable end, which was lost last summer, during an attempt to make a con-nection with the Cuban shore, has been picked up,

nd is now working admirably. A steamer from Cadiz has arrived here with two generals, 590 regular troops, and Mr. Roberts, the newly appointed Minister of Spain to the United

States. News from Santiago to the 10th inst. says there were five deaths from cholera in that city on the 9th. The epidemic was increasing in violence in

the surrounding neighborhood. The negroes were destitute of food, and were re-turning to their plantations. There were frequent desertions from the ranks of the volunteers, the men fearing the cholera.

LIVERPOOL, Feb. 17.-The American ship Southern Eagle, from this port on February 4, for Boston, has returned to Milford Haven damaged by a severe gale, and will discharge her cargo.

MADRID. Feb. 17 .- Much excitement was created yesterday by an unsuccessful attempt to assassinate General Prim. Three persons believed to be implicated in the affair have been arrested.

# FROM WASHINGTON.

Cabinet Officers and Political Aspirants -News From Cuba.

WASHINGTON, Feb. 17 .- General Sickies has arrived here, and General Sherman is expected next week. Their names are freely spoken of in connection with Cabinet and other offices. It is rumored that General Sickles is figuring for a very lucrative Federal office in New York. General Grant's reticence about his Cabinet has only intensified the interest of the politicians and office seekers. A number of Cabinet slates have been made, and they all jinclude the name of Mr. Evarts as Attorney-General, Great efforts are made to secure a Cabinet position for Senator Wade, and it is thought that Mr. Colfax's influence will turn the scale in Wade's favor.

The position of Cuba excites great interest It is expected that the revolutionary party wil proclaim the independence of the island. In In that case our Government will immediately recognize the new Government, and extend belingerent rights to it, and the privileges of neutrality. It will then be open to both parties te obtain men, money, and arms from abroad. And it is not doubted that American sympathy will turn the scale in favor of free Cuba.

### National Currency.

The House, by a vote of 90 to 16, has adopted Coburn's amendment to the Supplementary Currency act. It provides for an increase of national bank currency, to supply the want which exists at the South and West, instead of a redistribution of currency now authorized by Western and Eouthern members voted for it almost solid.

### The President's Amnesty.

The Senate Judiciary Committee made a report to-day on the subject of the President's last annesty proclamation. The committee's report is very long, and reviews the whole question of the Executive power in the pre-mises, and concludes with the opinion that the Bracident issued it with no subject by under the President issued it with no authority under the Constitution or laws. The committee also report against the admission of Miller as Senator from Georgia, and also in favor of striking out the word "white" where it occurs in the naturalization laws.

### Southern Press Convention.

MOBILE, Feb. 17 .- The Southern Press Oon vention meets to-day. Delegates have arrived from North and South Carolins, Georgia, Alabama, Mississippi, and Tennessee.

### Fire in Boston.

Boston, Feb. 17.-A fire this morning de-stroyed the Congregational Church on Foster street, in Melrose. The loss is estimated at \$20,000. The property was insured for \$10,000.

### From Wheeling.

WHEELING, Feb. 17 .- The bill locating the apital of West Virginia at Parkersburg passed the House this morning by a vote of 29 to 23, and was reported to the Senate.

-A curiosity of meanness has been exhibited in San Francisco. During the settlement of an estate in that city, on the 24th o' January, it was discovered that a brother of the deceased had charged the estate \$4 for loss of time while attending the funeral.


