

In the House of Lords to-night the Marquis of Salisbury wanted to know if the government indorsed the policy advocated by Mr. Bright, that the people must be placed in possession of land in Ireland in greater numbers. He said the present uncertainty as to the position of the government on the land question was very injurious. Earl Granville, in reply, said he must decline to open the question. A bill on the subject would be introduced at the next session. He assured the House that the government would maintain the rights of property.


