-A mass meeting of journeymen carpenters was held yesterday morning, at the hall Broad and Arch streets, for the purpose of hearing re-oorts from the different employers in relation to the payment of \$3:50 per day for labor. Mr. Gowan was appointed chairman of the meeting. The committees from the sub-districts reported that they had visited a large number of shops, where the men signified their intention of join-ing those already on the strike. In the evening another meeting was held in front of the hall Broad and Arch streets, when addresses were made setting out the strike of the laboratory of the laboratory. made, setting forth the grievances of the laboring classes and the importance of a more liberal compensation for their services. The impression prevailed that the necessity for a long continu-ance of the strike would be obviated by the employers acceding to the demand of the journeymen.

A contribution of cut flowers attracted a great deal of notice as also did a sample of unusually fine strawberries and a quantity of musbrooms. MADDID, May 18.—The Minister of Finance to-day submitted the budget to the Cortes. PARIS, May 18.—The negotiations for a conference between France and Belgium have been

DUBLIN, May 18.- The Archbishop of Cashel, the Rev. Dr. Patrick Leahy, in a pastoral letter, refers to recent outrages committed in the south of Ireland. He considers it lamentable that the acts of a few desperadoes should tarnish the fame of Tipperary, and emphatically denies the existence of any agrarian conspiracy. The outrages, he says, were the result of the unhappy relations existing between the landlord and tenant, and the settlement of the land question in Ireland would be sure to diminish the num ber of such unfortunate occurrences. The pas toral bids the dissatisfied tenants to look with hope to the Imperial Legislature, and points out the danger of estranging and disgusting England by the commission of such outrages as

have recently been perpetiated. HAVANA, May 18.—Another battalion of mobilized negro troops left to-day for active service in the field.

The failure of Schepler & Co., in New York, causes some uncasiness in commercial circles here.

The Diario contains a report that the insurgents have burned the towns of Sabonica, Cas-corro and Geraimaro, but the Voz de Cuba doubts it.

The reports previously received from both Spanish and insurgent sources greatly exagger-ated the fight at Las Tunas, on May 3d. More reliable accounts, now at hand, reduce the af-fair to a mere skirmish. The Spanish and rebel troops are suffering equally from fevers, and it is said that many of the latter are dying from want of shelter and medical attendance

Trains are again running on the Puerto Prin-

cipe and Nuevitas Rallroad. Cane grinding has been interrupted in some localities on the North and South coasts by heavy

The United States gunboat Penobscot has arrived here.

LONDON, May 18.—The Standard of to-day, in an article on the Alabama claims treaty, says the idea of awaiting further expressions from Parliament and Congress commits the business to an indefinite postponement. England's sentiments have been clearly pronounced, but she is still prepared to submit to the proper tribunals the question of wrongs and damages; but any attempt to reopen the controversy on preposterous grounds, whatever the American senti-ment may be, is absurd. From this position England cannot recede.

Vizier, Minister of Foreign Affairs, to the Repre-sentatives of the Sublime Porte at Paris, London, Vienna, Berlin, St. Petersburg, and Flo rence,-Sir:-The confidence which our august Sovereign reposed in the equity and disinterestedness of the great powers in adhering, without the least hesitation, to the reunion of a con-ference to consider our differences with Greece, has been fully justified.

The judgment which this diplomatic Areopagus unanimously rendered is a reconsecration of the sound principles of morals and law. It demonsound principles of monus and haw. It demon-strates to the cycs of the entire world that jus-tice is yet sufficiently powerful not to permit mere ambition to trouble the peace of neighbor-ing States. By order of his Imperial Majesty I invite you to express to the Cabinet of his Ma-jesty the most sincere thanks of the Sublime Porte for the efficacious co-operation he has been pleased to lend to the pacific solution of a conflict which we have done everything to avoid, and which Greece has sought by all means to embitter and prolong. The past conduct of Greece, and the conclu-

sion of the proclamation addressed to the Hellenic people by the new ministry, are not such as to inspire us with great confidence in our fa-ture relations with Greece. A vigilant surveil-lance on the part of the great powers appear to us indispensable to insure the reality of the promises Greece has been obliged to make to the Conerfence of Paris.

In thus expressing ourselves, we intend no complaints by anticipation. We protest against all suspicions of an *arriere pensee* in regard to the kingdom of Greece It will find the imperial Government always ready to do everything compatible with its rights and dignity to maintain amicable relations.

Nothing will be done on our part to disturb that good harmony which it only depends on Greece to establish between the two countries. What we desire is to announce now, which the proclamations spoken of above necessitate, that if, to speak frankly, Greece, notwithstand-ing her engagement, begins to follow again the same line of conduct which almost compromised the peace of Europe, the responsibility for the consequences of such a state of things will rest entirely with her. We will not tolerate in any case that one Hellenic Government, under the mask of revolutionary committees, shall con-tinue and endeavor to mislead the minds of our Greek population, to give to the eyes of Europe the appearance of coming to the "ald of co-religionists who groan under the yoke of the Turks.

Our Greek population only ask to be let alone and to deve op their well-being. They are more and more convinced that the quality of the different races that people Turkey is henceforth the fundamental law of the empire, exemplified every day in proofs which are notorious. Our august master has more than once proclaimed this great principle, and watches himself, with-out ceasing, the realization of progress. It is not necessary to insist upon the trath of what I advance; facts sufficiently attest it.
