NEWS SUMMARY.

City Affairs.

-The committee to whom was entrusted the preparation of a medal commemorative of the semi-centennial anniversary of St. John's Commandery, No. 4, have completed their labors. Upon the obverse there is a cross and shield. with the following inscription:-"In Hoe Signo Vinces. Be Thou Faithful Unto Death. St. Vinces. Be Thou Faithful Unto Death. St. John's Commandery, No. 4, Masonic Knights Templar, Philadelphia." On the reverse:— "Commandery No. 4, K. T., Semi-Centennial Anniversary, June 15, 1869. Constituted June 15, 1819. Stationed at Philadelphia." The committee have had three kinds prepared—gold, silver, and bronze—in order that all who take part in the celebration may be afforded an onpart in the celebration may be afforded an op-

portunity of making a choice. -A large meeting of journeymen house painters was held last evening at the hall, Eighth and Locust streets. The President, Montgomery Cochran, on taking his seat, congratulated the journeymen who had obtained the advance of \$3.50 per day upon the result. The aunouncement was made that thirty firms were paying \$3.50 per day.

-Revenue Officer Heilman had another hunt yesterday after stills used in the manufacture of whisky through the Richmond district. Two copper stills were found in the rear of William street, between Salmon and Belgrade, but whisky was not being distilled in them. There was, however, considerable mash on the premises, which the officers were obliged to leave, as it could not be removed, and no means were at hand to destroy the casks. The stills were carried away. Back of No, 1541 Salmon street a still was found in operation. It was torn from its foundation, and taken with the others to a bonded warehouse. About fifty hogsheads of mash were found in different parts of the district.

-The city contest case was continued yesterday, when the counsel for contestants having asked the court to throw out the vote of the firs hour in the Sixth division, Seventeenth ward. because the election was conducted by only a portion of the officers, several persons, whose names appear on the list of voters during the hour, were called and testified that they voted the Democratic ticket.

-A man, apparently 80 years old, fell dead yesterday in one of the passenger cars at Seventeenth and Pine streets. He was dressed in an entire suit of blue cloth. From papers found on him having the name of James McCord written upon them, that is believed to have been his name.

-A meeting of the Pennsylvania Reserve Association, with reference to making the ar-rangements for the grand demonstration which takes place in West Chester on June 2, was held last evening in the District Court room. Major Richard M. Ellis presided, and Dr. I. J. Clark acted as secretary. The committee to provide transportation, music, etc., reported that all the necessary preliminaries had been arranged for the occasion. The meeting then adjourned,

days. -The steamer Cora S. was sunk on her trip between Cincinnati and the Arkansas river, on Tuesday morning. There was a valuable cargo on board.

THE ANNAPOLIS ACADEMY.

Preficiency of the Cadeta Practice Ashore and Allont Distinguished Visitors Present. ANNAPOLIS, Md., May 26. The exercises at the Naval Academy, yesterday afternoon, consisted of battalion infantry drill, under command of Licutenant-Commander S. P. Gillett; howitzer and mortar practice, and in the evening a grand symmastic tournament, boxing, wrestling, flying trapeze, and Zouave drill, which was concluded about 11 o'clock, when a brilliant dance commenced, led off by Mrs. Admiral Porter and Commander Gillett. Dancing was kept up until 8 o clock this morning. This forenoon President Grant, with Admiral Porter, rode over Strawberry Hill, the farm last year purchased by the Government and annexed to the Naval Academy grounds. A fine shell road has been made through the grounds, and the President and Admiral enjoyed the ride. The latter held the ribbons

At 11 o'clock the exercises at the Academy commenced with practice of seamanship-in sail auturing, reefing, tacking ship, furting sails, etc.—on the sloop Dale, which was moored along-aide the wharf, under the stern of the old ship Constitution, from the quarterdeck of which the President, Admiral Porter, Secretary Borie, and he Board of Visitors witnessed the exercises. Mrs. Grant, Mrs. Admiral Porter, and other ladies were present, There were about two hundred and twenty-five middles exercising on the Dale. ATTORNEY-GENERAL HOAR.

An Important Opinion Relative to National Banks Adopting the Old State Bank System. The following opinion has just been promulrated:-

ATTORNEY-GENERAL'S OFFICE, May 16, 1869. Sir:-In your letter of April 6, 1869, transmit-

ing a copy of a letter from the Comptroller of the Currency of the same date, calling attention to his letter of October 18, 1868, and referring to a letter of the late Secretary of the Treasury to my predecessor of October 16, 1865, you request my advice upon the points presented therewith, which have been carefully considered, and upon which I am now prepared to submit my opinion. The Comptroller states in his letter of pril 6 that he is informed, and has reason to believe, that quite a number of national banks in the city and State of New York, in order to avoid the restrictions and limitations imposed by act of Congress, contemplate a return to the State system, under what they now call the enabling act, passed by the Legislature of that State for that purpose; and in his letter of October 15, 1868, he states that the President and directors of the National Mechanics' and Farmers' Bank of Albany, an institution organized under act of Congress to provide a national currency, secured by a pledge of United States bonds, and to provide for the circulation and redemption thereof, passed June 8, 1864, claim to have converted their bank into a State banking association, under the provi-sions of an act passed by the Legislature of the State of New York, April 20, 1862, entitled "An act enabling national banking associations to become State banking associations," etc., and that by virtue of such conversions they are absolved from all allegiance, and responsibility as a national bank to this office, and to the requirements of the act of Congress. I am of the opinion that it is not within the power of the Legislature of New York to alter, modify, add to, or diminish the powers, duties or liabilities created in or conferred upon a banking association established under ct of Congress. The powers, privileges, and dutics of a corporated body are wholly derived from the sovereignty which gave it existence. The Legislature of New York may undoubtedly incorporate or provide by law for the incorpora-tion of banking associations in that State: but banking associations thus created are new and distinct bodies corporate, with which corporations deriving their existence from the United States cannot be merged, or in any manner identified, without authority of Congress. Any law-ful contract which a national banking association might make with a private person, or with another corporation, may undoubtedly be made with a corporation established by the State of New York for banking purposes, and authorized by that State to enter into such a contract on the dissolution of a national banking association, in the manner provided by the laws of the United States. The property of such an asso-clation may be disposed of by its owners to any other parties competent by the local law to receive such transfer, so far as the restrictions, liabilities, and duties imposed by act of Congress upon the corporation winding up its affairs will admit. But it seems to me that it is a misuse of language to say that the National Banking Association is in any sense changed into a banking corporation created by the laws of the State and merged in it, and I can perceive no authority existing in the Legislature of New York by which the property of the national corporation shall, by act of law and without any conveyance or transfer, be vested and become the property of such State banking association. The statutes of New York city, indeed, provide for the crea-tion of a corporation, clothed with the capacity to receive a transfer of property in such manner as the Legislature of the State may determine, and as far as its capacity to receive is concerned, the Legislature of that State has full control over the subject, but the creation of the capacity on the new corporation is an entirely different thing from the attempt to transfer from the national corporation its property. The powers and mode of action of the national corporation depend wholly upon the action of the National Legislature. I am further of the opinion that when a national banking association has taken the proper measures for its own dissolution in conformity with its articles of association, and under the provisions of the act of Congress of June 3, 1864, such resolution is not complete until the necessary action has been taken for the redemption of its circulating notes, either by actually redeeming them and surrendering them to the Comptroller of the Currency, or by de-positing an amount of Treasury notes with him idequate to their redemption, as provided by that act, and that until these acts are com pleted the existence of the national banking association continues under the law; that its capital cannot be lawfully distributed among its shareholders, or transferred to any other person or body corporate; that it remains under the supervision of the Comptroller of the Currency in the manner and to the extent prescribed by act of Congress to the same extent as before its liquidation commenced that it is still required to make regular and proper reports and returns of its condition to the Comptroller in the manner required by the statute: that it is subject to the penalty which the statute provides for a failure to make such returns; that its obligation to keep its reserve of lawful money still continues; that its directors must still be the owners of so much of its capital stock as the statute directs, and that it unlawful to endanger the lien of the United States upon its assets by a transfer of them, without other consideration than the transformation of a new banking association by the same stockholders. It follows as a con-sequence that whatever remedies the act of sequence that whatever remedies the act of Congress gives for a violation of its provisions may be pursued by the Comptroller of the Cur-rency, whether such a remedy is to be found in obtaining a decree of forfeiture and the appoint-ment of a receiver, by the exaction and collec-tion of penalties only on injunction from a court

of equity, to restrain acts from which loss or danger to the rights of the United States may be reasonably apprehended, will depend, of course, upon the special facts of the case, and upon the nature and extent of the violations of is corporate duty, which the national banking esociation, undertaking to dissolve its corporate existence and liquidate its affairs, may be found to commit. I return herewith the papers transmitted.

FROM NEW YORK.

Proceedings of the Old School Presbyterian Assembly.

Despatch to The Ecening Telegraph.

NEW YORK, May 26.-The business session opened with prayer by the Moderator, the ual devotional exercises having been held at the Church of the Covenant in connection with the other Assembly. Before taking up the order of the day, which was reported by the commit tee to correspond with the officers of the Grand Army of the Republic, a communication was read from the proper officers of Long Island to the effect that the decoration of soldiers' graves would take place, according to previous an-nonucement, on the 30th inst., but that no decorating ceremony would take place. It con-cluded with an invitation to the Assembly to ttend at Cypress Hills Cemetery.

It was reported also from Long Island Presby-tery that it had rejected the proposed union on the basis proposed. It was hoped by the presytery, however, that a union would be consum nated on the common standard without refering the subject again to presbyteries. The first order of the day was taken up at ten o'clock The report of the Committee on Disabled Minis-Fund was presented to the house by Dr. W R. 

MADRID, May 26 .- The Cortes is now debating the clauses in the Constitution which refer to the colonies. Senor Castelar, alluding to Cuba, said if Spain had followed the example of England in respect to Canada, by granting the liberties which the colonies now claim for themselves, the outbreak in Cuba would have been prevented.

Serrano replied that General Dulce granted the required liberties when he entered the Cuban Government, but party spirit blinded some of the inbabitants to the intentions of the Home Government. By a demonstration of physical force, the rebellion had been suppressed. but moral disorder was disappearing very slowly. When the normal state of the island is restored. the Home Government, in conjunction with the Deputies of Cuba, will suppress slavery, and punish all persons engaged in the slave trade. PARIS, May 26 .- An accurate classification of the members of the new Corps Lagislatif cannot yet be made, as all the elections have not been decided, and the returns are incomplete. In fifty-nine districts the result is so close that a ballot is necessary. Of those candidates whose election is sure, forty-one were not members of the last Chamber. The opposition gain six new members, but lose three old ones. Dreole and Estange are elected.

FLORENCE, May 26. -Fourteen arrests have been made at Leghorn in connection with the attempted assassination of Colonel Greaville. It has been ascertained that political animosity. growing out of the conduct of Colonel Grenille at the siege of Rome, in 1819, was the cause of the assault.
