During the year the receipts were \$6121, exclu-sive of a donation of \$3000 made by Mrs. Ann Hertzog. All the money remaining on hand at Hertzog. All the money remaining on hand at the end of each year, after the payment of ex-penses, is donated to the Pennsylvania Bible


