NEWS SUMMARY.

City Affairs.

-A meeting of the iron workers of Kensington was held last evening at the James Page Library Company, Girard avenue, above Shackamaxon street, for the purpose of hearing the report of the committee appointed at a former meeting to offer a compromise to the employers of ten per cent. on their wages. The committee reported that they had the interview with the employers, and that their proposition had been rejected. A resolution was then adopted, declaring that they would resist any further reduction of wages. A committee was appointed to inform the employers of the result thus arrived

-A meeting of the Board of Publication of the Presbyterian Church was held yesterday afternoon, at the Publication House, Chesnut street, above Eighth, when the annual report, to be submitted to the General Assembly at their meeting in May, was presented. Since the last meeting the board have published 50 new volumes in the English language, besides a number in the Portuguese and German languages. The total number of publications during the year was 589,400.

During the year the board have employed 156 colporteurs, who have labored in twentythree States, besides others in Canada and Brazil, all of whom have been instrumental in circulating 110,000 volumes, also two and a half million pages of tracts. The receipts of the year were \$146,193, and the expenditures \$145,892. The receipts for colportage and distribution exceeded those of the previous year about \$4448. The officers are:

The committee then reported that one person in each precinct be appointed to collect money to defray the expenses of the celebration of the ward; to employ music; the participants to be dressed in black coats and pants, white vests and gloves, high hats and blue sashes; to carry transparencies; the ward delegation to be under the command of a chief marshal, to be selected, who shall appoint three aids. The report was adopted.

Mr. James Walker was then elected Chief Marshal of the delegation of the ward. After the transaction of some minor busi-

ness the meeting adjourned.

Philadelphia Commandery, No. 2, is one of the leading commanderies of the State, and includes in its membership some of our most prominent citizens.

-The meeting of the Philadelphia Fourth Presbytery took place last evening, at the Rev. Dr. Shepherd's Church, Buttonwood street, below Sixth. The opening sermon was preached by Rev. John W. Hutton, of the Greenwich Street Presbyterian Church, from the 6th chapter Gallatians, 14th verse. At the close of the discourse an organization was effected by electing Rev. Samuel W. Duffield Moderator, and Rev. Messrs. Hammer and Wright temporary clerks.

-Yesterday afternoon a meeting of the Pennsylvania Baptist Association was held at the Publication House, Arch street, below Sixth. Rev. Dr. Cathcart presided, and after devotional exercises the report was read by the Secretary, Rev. L. G. Beck, from which it appears that a large number of visits have been made and sermons preached among the poor. There were also 800 copies of the annual report distributed, and the receipts were \$4585.42. The expenses of the Agent, including postage and stationery, were \$6321.

-The goods, consisting of mohair cloth and kid gloves, to the value of \$1000, stolen from the store of Casselberry & Cadwalader, No. 880 Arch street, have been recovered by Detectives Tryon and Lukens and delivered to the firm.

-Dr. Francis De Elwart, Ben-Ali Pasha, Mark Misguische, and Ishmael Hassan, who were arrested on suspicion of having set fire to the Oriental store, No. 1306 Chesnut street, on Saturday evening last, were before Alderman Jones yesterday for a hearing. The evidence being insufficient to warrant their detention, they were discharged.

-Coroner Taylor held an inquest yesterday upon the body of Mary Lee, aged seventy years, who died suddenly at her residence No. 149 North Front street. Verdict, death from intemperance. Also, upon the body of George Franks, aged forty years, who died yesterday in the cellar of No. 628 Alaska street. Verdict, death from debility.

-Last evening a public temperance meeting was held in the Hall of the Young Men's Christian Association, which was well attended. An address was delivered on the subject of temperance by George H. Hick, Esq., which was well received. A recitation was also given by Master George H. Eddy.

-Last evening between 6 and 7 o'clock a gentleman, while riding in a Market street car, between Eleventh and Twenty-second streets, had his pocket picked of a portemonnaie containing \$40 and some papers.

-The Rev. John P. Conkey was installed pastor of the Sixth Presbyterian Church last evening. The devotional services were conducted by Rev. Dr. Rice, and the sermon was preached by Rev. H. C. McCook. A large congregation was in attendance.

-A gold watch and several coats were stolen on Monday from one of the upper rooms No. 924 Chesnut street.

-Robert Gilfillan, who resided at No. 1724 Montrose street, was found drowned yesterday at Tasker street wharf.

Hall Stanton, President, in the chair. Among the communications received was one notifying the board that the building to be erected on Third street, above Lombard, had been named the Fifth Section Grammar School. Approved.

A remonstrance was presented, signed by fifteen Controllers, against the continuance of the old system of music teaching in the schools, and also against the placing of any of the money to which the sections will be entitled, under a division of the fund, in the hands of a superintendent of music.

The annual report of the President was read. After referring to the origin of the public school system in Pennsylvania, by which it appeared that it was created fiftytwo years ago, and that the Board of Controllers was organized in 1818, with Roberts Vaux as President, who remained in the position up to the year 1831, it is stated that the number of children at school in 1818-19 was 2845, and that the cost of educating the same was \$23,040.85, of which sum \$1500 was expended for a lot of ground. At the close of the year 1869 there were 380 public schools and \$1,000 pupils in attendance.

The Grammar Schools number 55; the consolidated schools 33; secondary schools, 103; primary schools, 182; male teacher, 80; female teachers, 1435; total number of teachers employed, 1515; the number of male pupils, 41,069; female pupils, 40,214; the average number of pupils to each teacher, 51; number of pupils added during the year, 3715; number of children waiting admission, 4000. The whole amount expended in support of the schools last year was \$1,177,292'57; amount expended in salaries, \$697,610.48; for books and stationery, \$93,218.39; for incidentals, ground rents, fuel, etc., \$335,- $466 \cdot 79.$

The night schools were attended by over 2300 pupils, in charge of thirty-five or forty teachers. The total number of certificates awarded to applicants for permission to teach in the public schools was 178; of these 155 were educated in the Girls' Normal School. On the subject of compulsory education, the President strongly recommends that action be taken to save the large number of children now running the streets in idleness. He is of the opinion that industrial or rescue schools should be established for the children of worthless parents.

The report was referred to the Committee on Estimates to ascertain the cost of having it printed.






