

PENNSYLVANIA NOMINATIONS.

The Philadelphia Evening Bulletin, speaking of the nominations made at Harrisburg by the Opposition Convention says: Hon. Jno. M. Read, is one of the most eminent members of the Philadelphia bar, and a gentleman whose learning, experience and other qualities are such as would do honor to any tribunal. He was originally a Democrat, and was United States District Attorney for this district during the administration of President Van Buren. That office has never been filled from it was during his term of office. He was afterwards nominated by President Tyler for Judge of the Supreme Court of the United States; but the nomination was not acted on by the Senate, and on the accession of President Polk it was withdrawn and Judge Grier was nominated. In selecting Mr. Read as his candidate, the convention was only carrying out the determination to name no one who was not amply fitted to add dignity to the chief judicial tribunal of the State. Mr. Read's zealous co-operation with the opposition, in 1856 and '57, might alone have recommended him to the Convention and entitled him to its favorable consideration. But we are inclined to think that the fact of his perfect fitness for the office, as a lawyer of learning, experience and spotless integrity, were the chief reasons for his selection.

The nominee for Canal Commissioner, William E. Frazer, Esq., of Fayette Co., is a most excellent, intelligent and worthy gentleman. He was, during 1855, 1856 and 1857, a very useful member of the State Senate from the Westmoreland and Fayette District, having been elected by the American vote notwithstanding the strong Democratic vote in these two counties. The resolutions did not exactly suit Mr. C. A. Coffey. He wanted something said about popular sovereignty, and with instructions to report such a resolution. This met with considerable disapproval, and Mr. Coffey did not press the motion. The resolutions were unanimously adopted. Joseph R. Flanagan, Esq., was then called upon for a speech. He responded in an eloquent manner, and detailed the rise and progress of the People's movement in the city and State. His candidate for Judge had not succeeded, but now that the nomination had been made, he and the other Americans of the city would put their shoulders to the wheel and pull together. (Applaud.)

A delegate from Franklin county remarked that he would like to know the position of Mr. Jno. M. Read. This brought out Mr. McMichael, who said Mr. Read was in favor of protection to American industry. When he was a Democrat a few years ago, he always urged protection to the iron and coal interests of Pennsylvania.

One of the ministers, says the Princess Belgiojoso, in her Eastern travels, in very good circumstances, had three daughters. The minister perceived that no one made them an offer, thought it advisable to wait no longer. One Sunday he preached on matrimony. The text, "Increase and multiply," declaring to his congregation that it was a command, and not merely a counsel. He dilated with eloquence and warmth on the chaste pleasures of wedlock, and ended his sermon by offering his three daughters to any persons who were willing to take them. He added that, after the sermon, he would receive the names of the offerers, and that his choice would fall on those who possessed the best moral character. A factious Irishman who was present did not await the moment indicated by the priest to raise his voice; he requested that his name should be placed on the list for two.

When Colonel D. was a candidate for Congress in one of the north-western States he was opposed by a gentleman who had distinguished himself in the war of 1812. Discovering in the course of the canvass that his opponent's military reputation was operating strongly to his prejudice, he concluded to let the people know that he was not altogether unknown to fame as a soldier himself; and accordingly, in his next speech he expatiated on his achievements in the tented field as follows: "My competitor has told you of the services he rendered the country in the last war. Let me tell you that I, too, acted a humble part in that memorable contest. When the tocan of war summoned the chivalry of the West to rally to the defence of the national honor, I, fellow citizen, animated by that patriotic spirit which glows in every American bosom, hired a substitute, and his bones are now bleaching on the banks of the Raisin."

Mails on the Sabbath.—A petition to the Postmaster General has been got up at Knoxville, Tennessee, requesting him to discontinue the Sunday mail through East Tennessee. Similar petitions are said to be on foot between Richmond and New Orleans. A general striking up of the question of Sabbath observance seems to be determined on.

Mr. Ten Broeck, the American who lost so heavily at the England race last year, has been more successful on the English turf; his horse Mimosa beat Mr. Dawson's Bedworth in a match for \$1000 at Newark races. Bedworth was the favorite at two to one and kept the lead until near the winning post, when Mr. Ten Broeck's horse shot past him, and won by two lengths.

Before the 8th of November next, the Free States will elect 127 of the 236 members of the next United States House of Representatives, leaving nine to be elected in March and April next—three in New Hampshire, four in Connecticut and two in Rhode Island.

Laborers in Chicago are getting only seventy-five cents per day this season, and hundreds of men are out of employment.

A farmer in McLean county, Ill., has 15,000 acres in wheat, which he anticipates will yield 30,000 bushels.
