

CONGRESS OF THE UNITED STATES,

Begun and held at the City of Philadelphia, on Monday the fixth of December, one thousand seven hundred and ninety.

AN ACT providing Compensations for the Officers of the Judicial Courts of the United States, and for Jurors and Witnesses, and for other

Purposes.

Be it enacted by the Senate and House of Representatives of the United States of America, in Congress assembled. That there be allowed to the several officers following, in addition to the sees (except milage to the marshals) to which they are otherwise by law entitled, and also to jurors and witnesses, in the courts of the United States, the following compensations, that is to say: To the attorney of the United States for the district, for his expences and time in travelling from the place of his abode to any court of the United States, on which his attendance shall be requisite, at the rate of ten cents per mile going, and the same allowance for returning; to the clerk of the district court, for attending in the district or circuit court, sive dollars per day, and the like compensation for travelling, as is above allowed to the attorney for the district: to the clerk of the supreme court for attending in court, eight dollars per day; to the marshal of the the like compensation for travelling, as is above allowed to the attorney for the district: to the clerk of the supreme court for attending in court, eight dollars per day; to the marshal of the district, for attending the supreme, circuit or district courts, sive dollars per day; for summoning a grand jury, three dollars; and for summoning a petit jury, two dollars; and for ferving and returning a writ, five cents per mile for his necessary travel; to the grand and petit jurors, each fifty cents per day for attending in court, and for travelling, at the rate of fifty cents for every ten miles from their respective places of abode, to the place where the court is held, and the like allowance for returning: to witnesses summoned on the part of the United States, or in behalf of any prisoner to be tried for any capital offence in any of the courts thereof, the same compensation as is above allowed to grand and petit jurors. That the several officers above specified shall be deemed to have been entitled to the above respective compensations, from the time of their respective appointments; and that the grand and petit jurors and witnesses, who have heretofore attended, shall also be deemed entitled to the above compensation, in like manner as those who shall hereaster attend. That there shall also be paid to the marshal, the amount of the expence for suel, candles, and other reasonable contingencies for holding a court, as hath accrued or shall accrue; and the compensations to the grand and petit jurors and witnesses, shall be included in the account of, and paid to the marshal, to the use of, and be by him accordingly paid over to the several persons entitled to the same: and the accounts of the feveral officers for the compensations aforestid (except milage to the marshal, for the fervice of writs in civil causes) having been previously examined and certified by the judge of the district, shall be passed in the usual manner at, and the amount thereof paid out of the treasury of the United States, and a sum arisin

a fum ariting from the fines and torfettures to the United States, and equal to the amount thereof, is hereby appropriated for the payment of the above accounts.

And be it further enacted, That instead of the provisions in that respect heretofore made, the first selfion of the circuit courts in the eastern circuit, after the passing of this act, shall commence at the times following, that is to say: In New-York district, on the fifth, and in Connecticut district, on the twenty-fifth days of April next, in Massachusetts district, on the twelfth, and in New-Hampshire district, on the twenty-fourth days of May next: and April next, in Massachusetts district, on the twelfth, and in New-Hampshire district, on the twenty-fourth days of May next; and in Rhode-Island district, on the seventh day of June next; and the subsequent sessions in the respective districts, on the like days of every fixth calendar month thereafter, except when any of those days shall happen on a Sunday, and then the sessions of the said circuit court shall be held in New-Hampshire district, at Portsmouth and Exeter alternately, beginning at the first: In Massachusetts district, at Boston; in Rhode-Island district, at Newport and Providence, alternately, beginning at the first; in Connecticut district, at Hartford and New-Haven, alternately, beginning at the last; and in New-York district, at the city of New-York only.

And be it further enacted, That from and after the passing of this act, instead of the provisions in the act for that purpose, the sessions of the circuit court for the district of Virginia, shall be holden in the city of Richmond only.

And be it further enacted, That this act shall continue in force until the end of the next session of Congress, and no longer.

The design of this compilation was intimated to Congres, and honored with their approbation.—On the 20th July, 1778, their committee, to whom his memorial was referred, reported it as their "Opinion, that Mr. Hazard's undertaking is laudable and deserves the public patronage and encouragement, as being productive of public utility;" Whereupon they "Resolved, That it be recommended to the Governors, Presidents, and Executive Powers of the several states in the union, to assist Mr. Hazard, and give facility to his labors; and that for this purpose he be admitted to an inspection of public records, and be surnished without expence with copies of such papers as he may judge will conduce to the valuable end he hath in view.

He was, of consequence, admitted to the inspection and use both of public records, and the collections made by individuals, from whence this compilation (much the largest he has ever met with on the subject, and, he slatters himself, the largest ever made in America) was formed. It has since met the approbation of many eminent characters, and even in its manuscript state, has facilitated the settlement of some important controversies.
