LOCAL AND PERSONAL.

IMPORTANT TO DRUGGISTS.—The following section of the new Penal Code, passed by the Legislature last winter, is of great importance to those who deal in drugs of any kind which are used as poisons:

"No apothecary, druggist or other person shall sell or dispose of by retail any morphia, strychnia, arsenic, prussic acid or corrosive arsenic, except upon the prescription of a physician, and the personal application of some person who is a resident of the town or place in which such sale shall be made. In all cases of such sale the word poison shall be carefully and legibly marked on the label, package, bottle or other vessel or thing in which such poison is contained; and when sold or disposed of otherwise than under the prescription of a physician, the apothecary, druggist or other person selling or disposing of the same, shall note in a register, kept for that purpose, the name and residence of the person to whom such sale was made, the quantity sold and the date of such sale.

Any person offending herein shall be guilty of a misdemeanor, and on conviction, be sentenced to pay a fine not exceeding fifty dollars."

It will be seen that no sale can be made except upon the prescription of a physician or to an inhabitant of the place, or in a place in which the name and the residence of the purchaser, the date of the sale and quantity sold, shall be kept.

THE RAIN.—Our "oldest inhabitants" state that they cannot recollect ever before having witnessed such continual heavy rains as those which have fallen hereabouts within the last week. For a length of time the rain fell in a constant succession of showers, accompanied generally in the evening and during the night with thunder and lightning. The country roads are in a bad condition, and the streams in every direction, have been overflowing their embankments and doing much damage. On Wallace's run one of the bridges of the Belleville and Shawnee railroad was arrested by the flood. The bridge was a trestle bridge, and the flood recently floated an iron bridge in all directions, and the water was so high that it was necessary to have the water in the trestle bridge sustained in consequence of high water. No mail was received here through from Lewistown from Thursday the 10th until Monday the 14th inst. The Lock Haven mail was also detained. It is said that the Belleville canal has been much injured, and that it will be some time before it will be repaired.

The Murder at Danville. The Danville Democrat of last Saturday, gives the following account of the recent murder at Danville.

On last Sunday evening between 8 and 9 o'clock when many of our citizens were assembled at the dancing school in the town, the school hall toward all men in their hearts, the school hall was busy in another part of the town, causing the foul and fatal murder of a fellow being in cold blood! An Irishman employed as a workman in the Montour rolling mills by the name of Andrew McKenley, deliberately stabbed one Thomas Shevlard, in the groin, causing his death almost instantly. There seemed to have been no apparent provocation, and the consequent excitement among the crowd who were attracted to the spot by the cry of "murder," was intense. So much so, that it was with difficulty Charles Pratt, assisted by a few energetic citizens, could take him safely to the jail. When Creutz arrested him, he was conveyed under the bed in his own house, having been previously chased through several streets. The inquest was held before Equerry Russell on Monday afternoon.

John Shevlard testified that he saw the prisoner make a stroke at Thomas Shevlard; that he caught the latter in his arms; that he saw a wound inflicted on Thomas Shevlard's back, about the size of a silver dollar, and that about 10 or 15 minutes afterwards he heard the cry of "murder."

Patrick Burns testified that he saw McKenley and Shevlard quarrel in the early part of the Sunday evening; that McKenley was afterwards hunting for his knife, and swore by his maker, that if he was to find his knife, that he would rip Thomas Shevlard's entrails out, and that about 10 or 15 minutes afterwards he heard the cry of "murder."

Andrew McKenley, the murderer, is 60 years of age, about 5 feet 3 inches in height, of stout frame, large, broad and florid face, but balding, and is an Irishman by birth, although he resided for 20 years just previous to his arrival in this country, (which was about 6 years ago) in the city of Glasgow, in Scotland. There he has yet three boys living, the oldest of whom is now about 25 years of age. He is married to his second wife, but has no children with her, and also belongs to the Roman Catholic Church. In regard to the murder, he denies knowing anything about it, but says that he is unconscious of anything that happened until he found himself the next morning huddled in jail.

The trial will in all probability come off at the May session of our court, which will commence on Monday the 21st inst.
