ELECTION PROCLAMATION

FOR THE ELECTION OF ELECTORS OF A PRESIDENT AND VICE PRESIDENT OF THE UNITED STATES.

WHEREAS, By an Act of the General Assembly of the Commonwealth of Pennsylvania, and the several counties of this Commonwealth, qualified to vote for the members of the General Assembly shall hold an Election at the same place at which the said members shall have been voted for at the preceding election, and the day of said Election shall be the first Monday of November in the year of our Lord one thousand eight hundred and forty, and on the same day in every fourth year thereafter, for the purpose of electing ELECTORS of President and Vice President of the United States.

And that the several Judges, Justices and Clerks who shall have the preceding first Monday of November next, and those hereinafter appointed to attend and perform the duties of such election, shall also themselves swear to be bona fide citizens, and in pursuance of their lawful calling, is within the district, and not for the purpose of voting there.

And that every person, excepting Justices of the Peace, who shall hold an office in any State, Territory, District, or any city or incorporated district, who is a commissioned officer or agent, who is or shall be employed under the Legislative, Executive or Judiciary of this State, or in any city or incorporated district, or who shall hold any office in any State, Territory, District, or in any city or incorporated district, shall be ineligible to vote at such election.
